ORDINANCE NO. 172

An ordinance Amending the Multnomah County Comprehensive Framework Plan by adopting the Multnomah County Bikeway Corridor Concept Plan.

Multnomah County ordains as follows:

Section 1. Purpose and Policy.

A. The Board of County Commissioners of Multnomah County recognizes that the Multnomah County Comprehensive Framework Plan requires the formulation of a bicycle circulation plan and a study of the feasibility of developing a pedestrian and bicycle system.

B. The Board further recognizes that a bikeway plan is necessary to the proper expenditure of funds under ORS Chapter 366, and to grant application requests for the construction of bikeway facilities in unincorporated Multnomah County.

C. The Board takes notice that the staff of the Department of Environmental Services has prepared a Bikeway Corridor Concept Plan ("Bikeway Plan") which consists of a text and a map; that the Multnomah County Citizens Advisory Committee on Bicycle and Pedestrian Paths met on June 7, 1978 and approved the proposed Bikeway Plan and that the staff of the Division of Parks and Memorials has met with other affected governmental jurisdictions of Portland, Gresham, and Troutdale concerning the Bikeway Plan.

D. The Board takes further notice that pursuant to Ordinance No. 133, the Planning Commission, after public hearing on July 11, 1978, for which notice was duly published, found the Bikeway Plan to be in conformance with the requirements of Policy No. 39 of the Multnomah County Comprehensive Framework Plan and with statewide planning goals 1, 6, 8, 12, and 13, and therefore recommended adoption of the Bikeway Plan by

the Board.


Section 2. Amendment.

The Multnomah County Comprehensive Framework Plan is amended by adding thereto the "Multnomah County Bikeway Corridor Concept Plan, July 1978," consisting of a three page text and a map. Said Plan shall be kept on permanent file in the office of the Director of Planning and Development.

This ordinance being necessary for the health, safety and general welfare of the people of Multnomah County, shall take effect on the 30th day after its adoption pursuant to Section 5.50 of the Charter of Multnomah County.

Adopted this 31st day of August, 1978, being the date of its second reading before the Board of County Commissioners of Multnomah County, Oregon.
