A portion of Lot 32 and 33 Plat 2 of Luradell Acres and Lot 7 Maple Grove Heights, located in Section 30 T1S R1E W.M. Multnomah County, Oregon, more particularly described as follows:


Beginning at the most Southerly Southeast corner of Lot 1 South End, a duly recorded plat; thence S 41° 02' 04" W along the Westerly line of S.W. 48th Ave., 112.60 feet to an iron rod at the true point of beginning of the tract herein described. From the true point of beginning thence N 80° 58' 12" W 86.20 feet to an iron rod on the Easterly line of Lot 7 Maple Grove Heights, a duly recorded plat; thence along the Easterly line of Maple Grove Heights, N 0° 00' 23" E 24.5 feet to the Northeast corner of Lot 7; thence along the North line of Lot 7, West 99.69 feet to the Northwest corner thereof; thence along the Westerly line of Lot 7 in a Southerly direction, 80.86 feet more or less to the Southwesterly corner thereof; thence along the South line of Lot 7, S 84° 32' E 112.11 feet to the Southwest corner of Lot 7 and the Easterly line of Maple Grove Heights; thence along the Easterly line of Maple Grove Heights, S 0° 00' 23" W 52.42 feet to a point on the Northwesterly right of way line of S. W. 48th Ave.; thence along S.W. 48th Ave., N 34° 08' 45" E 36.33 feet to an iron rod; thence N 41° 02' 04" E 98.63 feet to an iron rod at the true point of beginning of the tract herein described.


