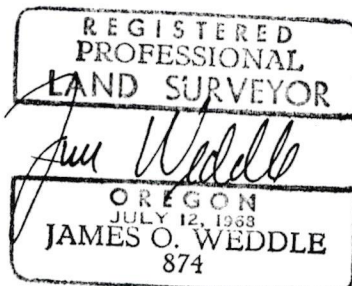

Rock Creek Road, aforesaid, 259.85 feet; thence South 85° 14' 32" East 767.68 feet to a point in the North-South centerline of Section 26; thence South 00° 35' 56" East along said line 200.88 feet to the point of beginning.
