ORDINANCE NO. 353

An ordinance amending Multnomah County Code: Chapter 5.10 to increase fees for food service and swimming pool inspection.

Multnomah County ordains as follows:

SECTION 1. FINDINGS

- A. The Multnomah County Board of County Commissioners finds that the costs of our delegated programs in food service and swimming pools exceeds the revenues for the programs. Costs for these programs are approximately \$500,000 a year, and the revenues are \$365,000 per year.
- B. According to Multnomah County Code 5.10.360, fees of the Department of Human Services shall be based generally on the cost of providing the services.
- C. Increasing revenue of delegated Health Sanitation programs will allow programs to approach the level of self-sufficiency. New fees will cover 90% of program costs.

SECTION 2. AMENDMENT

MCC 5.10.320 through 5.10.340 is amended to read as follows:

Food service inspection fee. For the services of the Department of Human Services in connection with issuance of food service licenses the department shall collect from every applicant, at the time of application, \$35 for each temporary license issued or applied for, ~~[\$125]~~ \$150 for each regular license issued or applied for, and ~~[\$65]~~ \$75 for each limited service license issued or applied for.

For licenses issued or applied for for the following special food service facilities, the following fees shall be charged:

5.10.340 Swimming pool license fee. For the services of the Department of Human Services in connection with the inspection of public swimming pools, public spa pools and bathhouses as those terms are defined in ORS 448.005 the department shall collect a [~~\$ 75~~] \$100 annual license fee from each applicant, except where more than one public swimming pool or public spa pool is located at the same address, in which case the annual license fee shall be as follows:

For the first three pools ~~[\$75]~~ \$100 each  
For each additional pool \$25




