1. What action are you requesting from the Board?

Approval of staffing adjustments resulting from the reclassification of four positions. This change will not impact the Health Department's total FTE for FY 2016.

Reclassify a 1.00 FTE Case Manager 2 to a 1.00 FTE Mental Health Consultant, position 714935, in the Mental Health and Addiction Services Division of the Health Department. Class Comp approved the reclassification effective 2/25/2015 (reclassification #3090). This position is responsible for developing and leading child and family team meetings; aligning the team with the youth and family vision, developing a shared team mission, identifying strengths as pathways to solutions, prioritizing needs; creating goals; leading discussions to determine medically appropriate mental health services, and coordination and consultation with schools, child welfare, judicial, health, correction, intellectual development disabilities, and mental health service providers. This change impacts program offer 40081 – Multnomah Wraparound

Reclassify a 1.00 FTE Case Manager 2 to a 1.00 FTE Clinical Services Specialist, position 714936, in the Mental Health and Addiction Services Division of the Health Department. Class Comp approved the reclassification effective 2/25/2015 (reclassification #3091). This position is

3. Explain the fiscal impact (current year and ongoing).

This budget modification has no fiscal impact in the current year. Budgeted personnel costs are within the pay scales of the new classifications or other budgeted line items have been adjusted so that the changes are budget neutral.

The reclassification of position 714934 to a Mental Health Consultant increased budgeted personnel cost by \$14,292, because the step at which the Mental Health Consultant is budgeted is higher than the step at which the Case Manager 2 is budgeted. The increase in cost is offset by a decrease in Temporary, Non Base Fringe, and Non Base Insurance for no net fiscal impact this fiscal year.

The reclassification of position 714935 to a Mental Health Consultant increased budgeted personnel cost by \$12,086, because the step at which the Mental Health Consultant is budgeted is higher than the step at which the Case Manager 2 is budgeted. The increase in cost is offset by a decrease in Temporary, Non Base Fringe, and Non Base Insurance for no net fiscal impact this fiscal year.

The reclassification of position 714936 to a Clinical Services Specialist increased budgeted personnel cost by \$8,758, because the step at which the Clinical Services Specialist is budgeted is higher than the step at which the Case Manager 2 is budgeted. The increase in cost is offset by a decrease in Temporary, Non Base Fringe, and Non Base Insurance for no net fiscal impact this fiscal year.

The reclassification of position 714937 to a Clinical Services Specialist increased budgeted personnel cost by \$11,074, because the step at which the Clinical Services Specialist is budgeted is higher than the step at which the Case Manager 2 is budgeted. The increase in cost is offset by a decrease in Temporary, Non Base Fringe, and Non Base Insurance for no net fiscal impact this

fiscal year.

In subsequent fiscal years, the reclassified positions will be subject to approved cost of living adjustments (COLA) and step and merit pay increases in accordance with collective bargaining agreements and county personnel rules. Increased costs will be funded within the department's budget.

7. What budgets are increased/decreased?

The Health Department's budget will have the following changes:

- Permanent personnel budget will increase by \$36,071
- Salary related expense budget will increase by \$7,526
- Insurance benefits budget will increase by \$2,613
- Temporary personnel budget will decrease by \$36,071
- Non Base Fringe budget will decrease by \$7,526
- Non Base Insurance budget will decrease by \$2,613

These changes will have no financial impact on the budget and do not change the Health Department's total FTE.

8. What do the changes accomplish?

Changes of classification for positions 714935, 714936, 714937, and 714934 better fit the duties of these positions as determined by the Class/Comp Unit of Central Human Resources.
