The above entitled matter is before the Board to consider the execution of a deed of dedication conveying certain real property to the use of the public for road purposes, and the acceptance of said deed; and

It appearing to the Board at this time that Multnomah County does not desire to utilize said property for the establishment of a county road, but that the premises are suitable as a dedicated street; and

It further appearing these parcels are within the corporate limits of the city of Gresham who has consented in writing for the county to dedicate and accept these parcels as public roads; and

It further appearing that it would be to the best interest of Multnomah County to execute said deed conveying certain real property to the public, and to accept said deed for dedicated street purposes; and that the Director of the Department of Environmental Services has recommended that said deed be executed and said property accepted for use as a dedicated street, but not as a county road;

NOW, THEREFORE, IT IS HEREBY ORDERED that said deed of Multnomah County, a political subdivision of the state of Oregon, conveying to the public the following described real property, situated in the county of Multnomah, state of Oregon, to-wit:


