How Many Needles Do You See in the Photo?

This pile of needles have been here most of the day. My wife called 911 and was hung up on after being told nobody was in imminent danger. She called non-emergency and was told that someone will be out tomorrow. I called 911 and reported an extreme bio-hazard and danger to children. I was told an officer would be out ASAP to pick it up. The officer called me and said they have small "sharps" containers and she would not have room. I called Mult Co. Needle Exchange and was told they are understaffed and do not have staff to do this today but would call me after they arrive tomorrow. All were told the location: under the stairs to the Tri-Met platform as they exit Laurelhurst and head north over the footbridge. Do your children walk by here as they use the school buses that are now being staged at that location while Grant High is being renovated? BTW: The brown splatter on the concrete wall is human excrement . How many needles do you see in this photo? Sorry to disappoint you. There will not be any winners. I have reported this information to the police.

Adam, you ask an important question: What, indeed, is the point? I'm going to read into your question a series of things, and since we don't know each other, I am likely to get wrong. And for starters, Nextdoor is precisely the correct place. The obvious point, to me, is the scream: the actual human recoil from the horror and cancer growing in our community, in our country. Mixed in with the horror is frustration: the tangible evidence of our social failure is not a recent development. This most recent, let's say last three years, rapid devolution of our culture still catches many people by surprise. Ask yourself if folks at the Tanasbourne Metro stop experience hundreds of heroin tainted needles, piling up on the sidewalk, where the children step over them on their way to school. Or the Nike campus. Or Chapman. The point, then, is to see if someone, anyone, in a position of power, notices. If there is someone who can DO something, can bust one move, can move the needle (sorry) just a little bit so we address the WHY of the posting: Why are so many Americans/Portlanders addicted? What are the correlations with mental health? What are the correlations with no jobs, no money, no hope? What are the correlations with PTSD? What are the correlations with "investor housing" that has driven up housing prices to such towering heights that no one working an hourly wage can afford a home in Portland? What are the correlations with AirB&B in the loss of housing? What are the correlations with a building industry that has spent 20+ years building high-end housing, but only a teensy bit of affordable housing? What is the correlation with the criminalization of addiction and the Prison Industrial Complex? Whose job is all this? The point, for me, is all of the above. The point is I don't want my kids getting stuck with a contaminated needle. The point is not sweeping it under the rug, and pretending that if we just swept it up and threw it away, the tangible horror of massive human failure, the needles, the shocking Vermeer painting of addiction and pain and suffering in that picture, which should be a shocking freaking wake up call, but is not, would be magically gone. In my admittedly sorry failure to advance solutions, other than to say that housing people first seems like a starting place, I can only scream along with Tom. I want to not be that one guy who starts screaming and doesn't stop, because the horror means that all you have left is screaming. Because screaming starts to look like a very logical response to a completely surreal, unacceptable reality. Because we want some elected official, somewhere, to say that

they, too, are screaming. And they are going to take care of this shit. We used to make fun of it, but go on: stick your head out the window and scream: I'M MAD AS HELL AND I'M NOT GOING TO TAKE IT ANYMORE

She called non-emergency and was told that someone will be out tomorrow. I called 911 and reported an extreme bio-hazard and danger to children. I was told an officer would be out ASAP to pick it up. The officer called me and said they have small "sharps" containers and she would not have room. I called Mult Co. Needle Exchange and was told they are understaffed and do not have staff to do this today but would call me after they arrive tomorrow. All were told the location: under the stairs to the Tri-Met platform as they exit Laurelhurst and head north over the footbridge. Do your children walk by here as they use the school buses that are now being staged at that location while Grant High is being renovated? BTW: The brown splatter on the concrete wall is human excrement . How many needles do you see in this photo? Sorry to disappoint you. There will not be any winners. I have reported this information to the police.

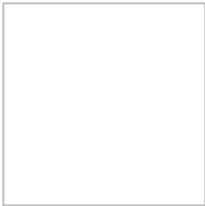

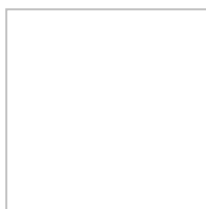

Adam, you ask an important question: What, indeed, is the point? I'm going to read into your question a series of things, and since we don't know each other, I am likely to get wrong. And for starters, Nextdoor is precisely the correct place. The obvious point, to me, is the scream: the actual human recoil from the horror and cancer growing in our community, in our country. Mixed in with the horror is frustration: the tangible evidence of our social failure is not a recent development. This most recent, let's say last three years, rapid devolution of our culture still catches many people by surprise. Ask yourself if folks at the Tanasbourne Metro stop experience hundreds of heroin tainted needles, piling up on the sidewalk, where the children step over them on their way to school. Or the Nike campus. Or Chapman. The point, then, is to see if someone, anyone, in a position of power, notices. If there is someone who can DO something, can bust one move, can move the needle (sorry) just a little bit so we address the WHY of the posting: Why are so many Americans/Portlanders addicted? What are the correlations with mental health? What are

the correlations with no jobs, no money, no hope? What are the correlations with PTSD? What are the correlations with "investor housing" that has driven up housing prices to such towering heights that no one working an hourly wage can afford a home in Portland? What are the correlations with AirB&B in the loss of housing? What are the correlations with a building industry that has spent 20+ years building high-end housing, but only a teensy bit of affordable housing? What is the correlation with the criminalization of addiction and the Prison Industrial Complex? Whose job is all this? The point, for me, is all of the above. I want to not be that one guy who starts screaming and doesn't stop, because the horror means that all you have left is screaming. Because screaming starts to look like a very logical response to a completely surreal, unacceptable reality. Because we want some elected official, somewhere, to say that they, too, are screaming. And they are going to take care of this shit. We used to make fun of it, but go on: stick your head out the window and scream: I'M MAD AS HELL AND I'M NOT GOING TO TAKE IT ANYMORE
