General Information

1. What action are you requesting from the Board?

Convene as the governing body of the Dunthorpe-Riverdale Service District to:

- Convene a Public Hearing to hear and consider any testimony from persons present and respond to questions about the budget and fiscal policy decisions.
- Approve Resolution adopting fiscal year 2014 – 2015 budget for the Dunthorpe-Riverdale Sanitary Service District No. 1 and make appropriations.

2. Please provide sufficient background information for the Board and the public to understand this issue. Please note which Program Offer this action affects and how it impacts the results.

The FY 2014-2015 Approved Budget sustains current service levels for maintenance and operations for the District. The District's \$850,000 capital program performs pipe rehabilitation on the Riverview Force Main Replacement project.

3. Explain the fiscal impact (current year and ongoing).

The District's budget was approved at \$2,307,000 for FY 2014 – 2015 (See Exhibit A to the Resolution). The District's current assessment is \$130.00 per month per property. For FY 2014 - 2015, the District proposes no change to the rate. The assessment provides the necessary operating resources to meet the District's proposed requirements.

4. Explain any legal and/or policy issues involved.

The District is a separate legal entity. Because of its size, it requires a budget committee. On April 17, 2014 in the Board Room of the Multnomah Building, the District budget committee was convened to hear the budget message and discuss the budget. The budget was approved as submitted.

Because the District covers a population of less than 100,000, it is not legally necessary to request a Tax Supervising & Conservation Commission (TSCC) hearing for the budget. However the approved budget for the District was submitted to TSCC and they have certified the budget. TSCC identified no recommendations or objections (See Exhibit B to the Resolution).

Today's public hearing fulfills the requirement of Oregon's Budget Law. The District's financial summary was published in the Oregonian and on the County's Home web page showing changes between the current adopted and the approved FY 2014 - 2015 budget.

The Board of County Commissioners convened as the governing body of the District can adopt the budget only after the budget hearing.

5. Explain any citizen and/or other government participation that has or will take place.

At the April 17, 2014 budget committee meeting a public hearing was opened, to hear and consider any testimony by the public about the budget. No testimony was received. At the May 29, 2014 Board Meeting a second public hearing will be held to hear and consider any testimony from persons present and respond to questions about the budget and fiscal policy decisions reflected in the approved budget.
