COMMENTS BEFORE BOARD OF MULTNOMAH COUNTY COMMISSIONERS

September 8, 2016


Portland's homeless issues have made headlines in the past 60 days and Sunday's Oregonian editorial 'Portland areas homeless need a short-term shelter plan that sticks' challenges County chair, Kafoury and Mayor Elect Wheeler to sit down and figure out how to use Wapato as a temporary homeless shelter. Certainly sheltering over 500 people before winter is a priority. Any discussion concerning Wapato, however, needs to move beyond "temporary" sleeping shelter to a resource center with temporary residency and a goal of getting people off the streets permanently. A facility with a mission to:


- Form a core group of social services providers, medical /dental, drug and alcohol treatment clinics, mental health awareness, job training and education all designed to support lifestyle changes toward self-sufficiency and permanent housing. At the first visit:
 - **Screen** residents for needs
 - **Treat** needs via coordinated teams of service providers
 - **Employ** residents with nearby businesses
 - **Transition** to permanent housing once residents have jobs

I believe this is the model Mr. Williams and his financial donors have in mind for Terminal 1, estimated to cost \$101m to bring a contaminated shell of a warehouse into livable condition. A land use appeal and a lawsuit have been filed against the City so the project may die. Other states have similar successful programs such as:

- Haven for Hope in Texas is twice the size of Wapato's capacity cost \$101 million to build has a \$16.182m operating budget. On any given night 1600 are sleeping on the campus. Average costs not available. I believe Chair Kafoury visited Haven for Hope.
- Fort Lyon in Colorado with a \$3.5m budget serves 250/annually, average cost \$14,000/per person. From 2013-2015 568 total served. 207 residents to housing, 116 permanent housing.
- Portland's Central City Common operates similar programs from 5 different locations. Central City has an annual operating budget of \$47 million and serves more than 13,000 annually, average \$3,615/person
- The 200 bed Hansen Building is estimated to cost \$1,315,000/annually or \$6,575/person. Services provided are information and referral on housing, health and income resources.
- The estimated annual cost of keeping a homeless person on the streets is between \$36 - \$40k, for Portland.

If the Portland/County Joint Commission want to end homelessness in Portland they will have to adopt and adapt one of the above programs. The cycle has to be broken or the revolving door will be with us forever. In reading these articles, it's very clear the shelters need to know who they are dealing with from the get-go. Addiction, mental illness, job loss/home loss, domestic abuse or the chronic homeless. Then we need a place for healing, job training, safety and a home. Wapato is large enough modern enough and well suited to become a state of the art resource center for in-depth homeless treatment. Wapato will not cost \$101 million to move into. Seek state, federal and donor funding, have TriMet put on another bus and a bus stop at the facility. Stop throwing roadblocks, look upon Wapato as an asset not a liability, support Commissioner Smith and open that facility and make some real progress.

I got out of the car and walked to the bus stop down a short road, which a healthy person can do about 1/8 mile away. It would take about 15-18 minutes north on I-5 in an auto or bus. Turn left on Marine Dr., then to a short street on Leadbetter to the entrance.

Across the is the Columbia Sportswear Warehouse, The Portland French Bakery and numerous other businesses so it is not isolated territory.

I would appreciate an answer to the question why this facility is not being considered as a temporary space. If it was a mistake to build it in the first place at costpayers money, then it should be put to use so that taxpayers won't feel "gypped" once again for a costly mistake. It's time to use Wapato as shelter

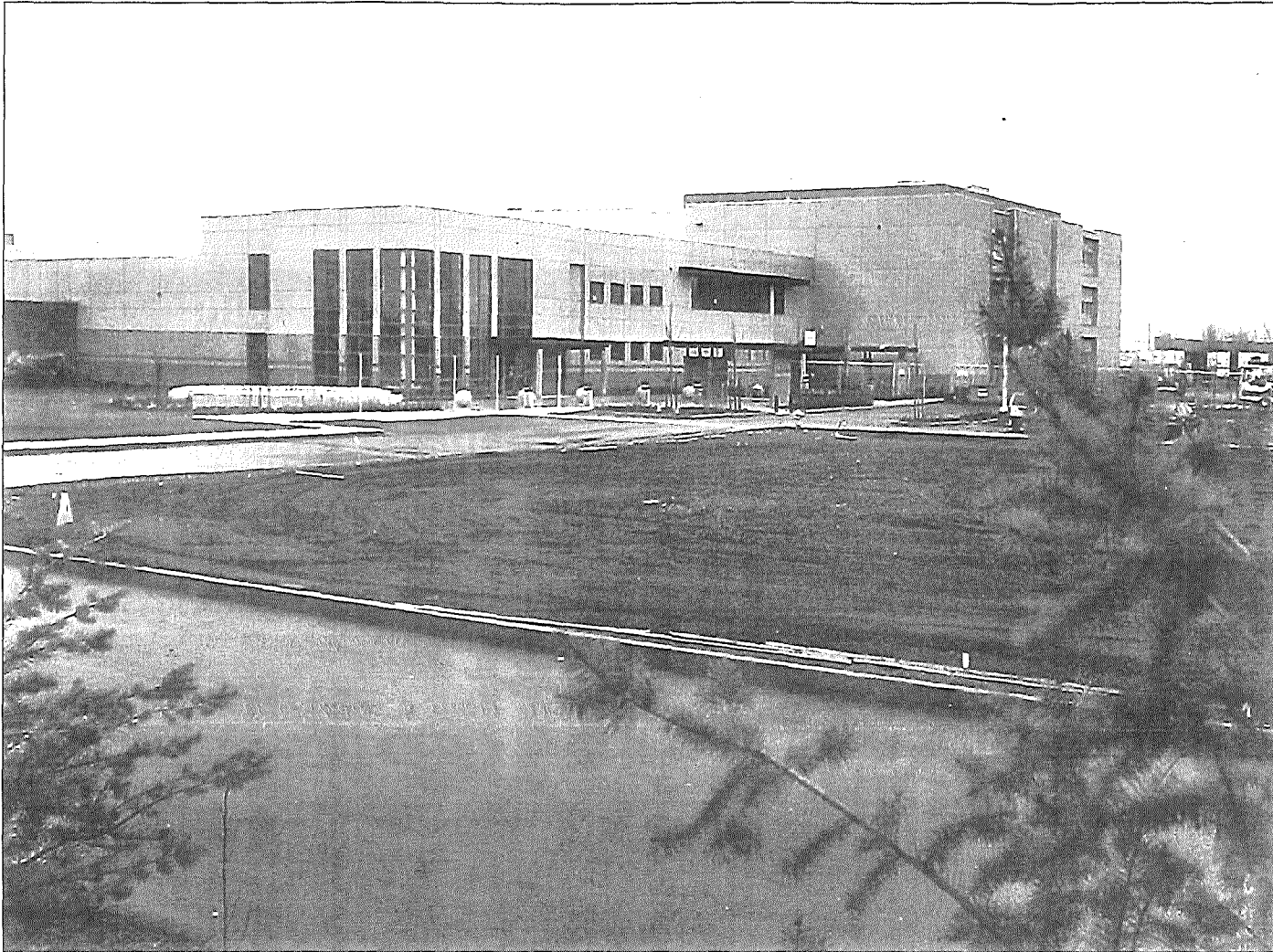
We are missing a giant opportunity to use the empty Wapato facility as a shelter. This region has homeless camps throughout our city going unchecked and unchanged without the Multnomah County Board of Commissioners offering up Wapato, a building that we spend more than \$500,000 a year on to sit empty. Wapato is a taxpayer-funded project that cost \$58 million to build.

The decision to not fully fund Wapato as a jail did not rest with this board. However, to use this facility in a manner that temporarily meets the crisis of homelessness in our community does rest with us.

We cannot continue to support placing our most vulnerable homeless residents in unhealthy buildings, contaminated warehouses, and unsafe environments that are zoned for commercial use. Industrial land must be kept to attract busi-

nesses offering family-wage jobs to our city and state. The struggle of homelessness does not warrant us treating people like they are inhuman when we are developing public policy solutions. We must always treat those who are homeless with dignity, respect and compassion.

Responding to my constituents, I urge the Multnomah County chair and Board of County Commissioners to support a resolution, ordinance or a vote to open Wapato as a homeless shelter immediately. We should not ask residents,

homeowners and families to accept chronic homelessness in their neighborhoods if we are not willing to use every resource and tool we have available. Furthermore, we should be embarrassed and meticulously critiqued for even contemplating asking the business community, and our taxpayers, to support shelters in their communities without us tirelessly exploring every possible option including putting Wapato on the table.

No more excuses!

Multnomah County has the

ability to partner with a number of social service providers, housing service providers, government assistance organizations, i.e., the Veterans Administration, Social Security, employment and training programs, regional transportation partners, public and private, in order to ensure access to the central city programs.

To assume that we cannot, collectively, work to ensure homeless individuals are connected to key services while residing at Wapato, fails to understand the infrastructure

that is part of Multnomah County.

We have the values and the leadership on our board to make the courageous and correct decision to serve our community members who are homeless in a facility.

Wapato is a facility that will not cost \$100 million to build. Wapato is a facility that does not come with enormous environmental issues. It is a facility that has the appropriate showers, toilets, kitchen, heating, cooling and community rooms that can serve 500 to 1,000

homeless residents ... today.

We need to step up our game, Multnomah County Board of Commissioners, and recognize that chronic homelessness is worsening by the day in our city and county. Affordable housing is an issue that will dominate our conversations for years to come.

The time is now for us to act.


