

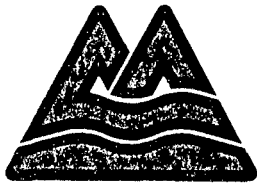

EAST COUNTY CARING COMMUNITY

PURPOSE

The goal of the East County Caring Community (ECCC) is to encourage and assist the people of East Multnomah County to care about each other and to promote individual and family self-sufficiency through a stronger sense of community. This service integration project is an outgrowth of the commitment by the Department of Human Resources (DHR) and Multnomah County to integrate services and the Leaders Roundtable efforts to develop "Caring Communities." The ECCC chose to focus on two Benchmarks: 1) **Basic Student Skills**; percentage of 11th grade students who achieve basic skills' mastery, and 2) **Readiness to Learn**; percentage of children entering kindergarten meeting specific developmental standards for their age. The following interim outcome measures were established: 1) **Reduce absenteeism and mobility by 10% in each of the three Family Resource Center site schools in 1993-94**, 2) **Reduce the number of immunization exclusions at each of the Family Resource Center site schools in 1993-94**, and 3) **Reduce the amount of time students and families wait before receiving services.**

The ECCC Operations Committee began working on the planning and implementation of the DHR Service Integration Project in January 1993 with a plan to: 1) **pool education and service resources across Centennial, Reynolds, and Gresham school districts to meet the needs of children and families involved with multiple agencies**, 2) **implement an automated inventory of educational and human resources in East Multnomah County**, and 3) **provide early support to pre-school students and their families to ensure the children are meeting age-appropriate developmental, social, and educational standards.** The plan includes screening all pre-kindergarten students for developmental levels and creating multi-agency plans with families of children "most at risk" of school failure. DHR, County and not-for-profit agency staff are currently located part time at three school Family Resource Centers (FRCs) with plans to increase staff hours over the next school year.

PARTNERS

The Caring Community Project began with broad representation from most segments of the community. The Operations Committee was formed to plan and implement the goals of both the Caring Community and the DHR Service Integration Project. In March 1994 the ECCC became the designated District Coordinating Team (DCT) for East Multnomah County. The Operations Committee includes representatives from:

The committee meets twice a month with an average attendance of 18 persons and adds new members as it evolves.

ACCOMPLISHMENTS

To date the ECCC has achieved the following;

- Memo of Agreement developed and signed by the three school districts and the DHR.
- Interim measures developed and agreed to by the Operations Committee and local, county, and state managers.
- Project manager hired.
- Needs assessment survey developed and circulated to members of the East County community.
- Computer equipment obtained to link state workers at the school Family Resource Centers to the state mainframe and the Information & Referral program.
- Business Partnership Mentoring Program at Hall Elementary (DHR Volunteer Program) developed and implemented; successfully expanded to Reynolds School District in the 1993-94 school year.
- Family Resource Centers (FRCs) opened for business in the three participating school districts.
- AFS worker outstationed full-time at the Harold Oliver FRC. Workers from other agencies staffed part-time in all three FRCs.
- Health Action Team formed to conduct immunization clinics (resulting in an approximately 43% reduction in immunization exclusions) at sites in the three participating school districts in October 1993 and May 1994.

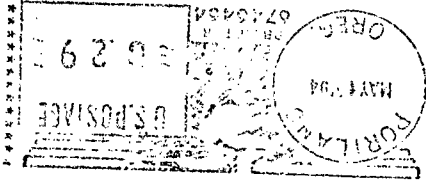

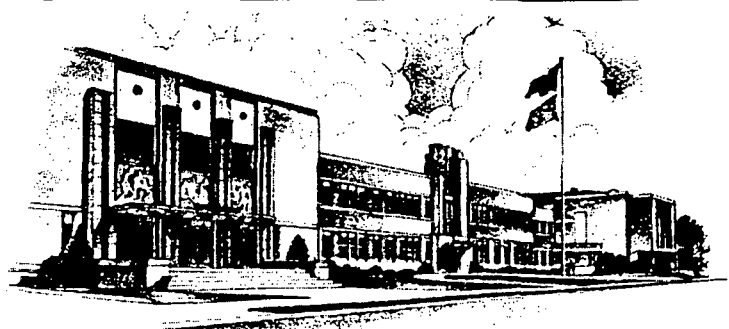


