Including reach-in and intensive A&D outpatient treatment service, housing with mentoring and employment services. This program is evidence based, and has successfully decreased the recidivism rate, resulting in a 33% reduction in arrests compared to a matched control group.
County Human Services	25020A	ADS Access and Early Intervention Services	3,602,827	6,054,290	0	(198,086)	(198,086)	0.00	198,086	<b>Older Americans Act funding:</b> This funding would help mitigate reductions to contracted community services for older adults (60+ years old) in Multnomah County. Impacts may include: eliminating family caregiver respite awards to 42 families; eliminating 1,000 hours of counseling on public benefits and community resource options for older adults; reducing contracts with Legal Services of Oregon and Elders in Action for legal and personal advocacy supports for older adults; and eliminating 10,000 home delivered or congregate meals for older adults. <b>Note:</b> In recent Special Session the Legislature allocated \$26 million for Senior Services/Programs, there isn't enough information at this point to ascertain if any of this would come to Multnomah County. Decisions on distribution of this funding will not happen until February 2014.
