Beginning at an iron rod marking the northwest corner of the southeast one-quarter of the northwest one-quarter of said Section 6; thence S 89° 47' 00" W along the south line of PLAINVIEW ACRES, a plat of record, a distance of 375.18 ft.; thence S 0° 42' 30" W a distance of 651.53 ft. to the south line of that tract of land described in deed to William G. Ackley and Laura Ackley, recorded Feb. 4, 1964 in Book 2207, Page 548, Records of Multnomah County; thence N 89° 33' 10" E along the south line of said Ackley tract a distance of 375.21 ft. to an iron pipe marking the southeast corner of said Ackley tract; thence S 0° 42' 30" W along the west line of the southeast one-quarter of the northwest one-quarter of said Section 6 a distance of 116.54 ft. to the intersection of said west line with the westerly R/W line of West Union Rd. (Co. Rd. No. 1642, also known as Cornelius Pass Road); thence northerly tracing said westerly R/W line as follows; along a spiral curve to the left, the chord of which bears N 26° 39' 32" E, 81.98 ft.; thence S 66° 45' 06" E, 10.00 ft.; thence along a spiral curve to the left, the chord of which bears N 17° 53' 22" E, 237.76 ft.; thence S 74° 40' 30" E, 50.00 ft.; thence N 15° 19' 30" E a distance of 175.59 ft. to the intersection of said westerly R/W line with the south line of that tract of land described in deed to Stanley Charles Pintarich, recorded Feb. 14, 1946 in Book 1015, Page 523, Records of Multnomah County; thence leaving said westerly R/W line and running N 89° 26' 17" W along the south line of said Pintarich tract a distance of 208.03 ft. to the southwest corner thereof; thence N 0° 42' 30" E along the west line of the southeast one-quarter of the northwest one-quarter of said Section 6 a distance of 312.77 ft. to the point of beginning.
