In 2010, the Board created the Advisory Committee on Sustainability and Innovation (ACSI) to promote sustainable policies and actions and to advise the county on regional, state or national sustainability policy matters. ACSI is a citizen advisory committee meant to harness community expertise in sustainability and drive innovation by bringing new ideas and best practices to Multnomah County.

In the 2016 calendar year ACSI members were active in advising the County on several important issues, including: strategies to address regional air quality; guidance around the development of the PropertyFit Commercial Property Assessed Clean Energy program; and support of the implementation of the 2015 Climate Action Plan. This briefing will highlight the role ACSI has played in providing advice to the County, offer a look ahead to ACSI priorities in 2017, and afford County Board of Commissioners the opportunity to ask questions of ACSI Chair Mary Peveto and ACSI Vice-Chair Bradford McKeown.
