ORDINANCE NO. 76

An Ordinance amending Section 25.24.010 of the Multnomah County Plumbing Code, as adopted by Ordinance No. 234, to delete the payment of fees for automatic fire sprinkler systems and to add payment of fees for building site feasibility statements.

Multnomah County ordains as follows:

Section 1. Amendment. Section 25.24.010 of the Multnomah County Plumbing Code, as adopted by Ordinance No. 234, is amended by deleting subsections C(22), C(23), C(24), C(25), C(26), C(27), C(28) and C(29) which read:

(22)	For automatic fire sprinkler systems, minimum:	\$ 5.00
	(a) With service supply line 2 inches or more in diameter:	10.00
(23)	For each sprinkler head up to and including fifty (50):	.10
(24)	For each sprinkler head over fifty (50):	.05
(25)	For each disposal or drain field:	3.00
(26)	For each trailer space in a trailer park or outside a trailer park having a drain or water terminal:	10.00
(27)	For each water supply system, whether or not installed with reference to a building:	5.00
(28)	For each fire hydrant or fire hose valve:	2.00
(29)	For a permit extension under Section 25.16.040(J):	5.00

by adding, subsections C(22), C(23), C(24), C(25) and C(26) to read;

(22)	For each disposal or drain field:	\$ 3.00
(23)	For each trailer space in a trailer park or outside a trailer park having a drain or water terminal:	10.00

and by adding subsection D to read:

D. Before a building site feasibility statement may be issued by the Multnomah County Department of Human Services, Health Division, under the Oregon Administrative Rules, the following fees shall be collected:

Section 2. Adoption. This ordinance, being necessary for the health, safety and welfare of the people of Multnomah County, shall take effect on the thirtieth day after its adoption, pursuant to Section 5.50 of the Charter of Multnomah County.
