### General Information

#### 1. What action are you requesting from the Board?

Approval to submit Letter of Intent for an EPA Green Infrastructure Technical Assistance award.

#### 2. Please provide sufficient background information for the Board and the public to understand this issue. Please note which Program Offer this action affects and how it impacts the results.

The County is seeking technical assistance through EPA's Green Infrastructure Program to develop a Stormwater Retrofit Strategy for County Roads. The EPA will provide technical assistance through one of its contractors, not through a grant. The assistance provided will be entirely in the form of work from contractors paid by EPA.

Multnomah County has regulatory responsibilities for stormwater management in our urban roadways. This technical assistance award will support the County's compliance with our National Pollution Discharge and Elimination System (NPDES) permit requirement to develop a Stormwater Retrofit Strategy. This assistance will also advance the County's staff knowledge of stormwater management techniques that is challenging with our current funding resources. The effort the implementation of Climate Action Plan Objective 3:

Watershed Health and would dovetail with Program Offer 91023, a one-time request to assess fish passage constraints due to culverts in County rights of way, and to develop priorities. The technical assistance award and Program Offer 91023 would support one another; neither is dependent on the other.

**3. Explain the fiscal impact (current year and ongoing).**

No local match is required for the Technical Assistance award. Since this is not a grant, there will be no direct fiscal impact; however, the County could receive between \$50,000 and \$100,000 in technical assistance. The possibility of leveraging Program Offer 91023 could strengthen the competitiveness of this request.

**4. Explain any legal and/or policy issues involved.**

This award will aid the County in complying with its NPDES permit conditions. It supports the implementation of Climate Action Plan Objective 3: Watershed Health.

**5. Explain any citizen and/or other government participation that has or will take place.**

The technical assistance and stormwater management knowledge gained through the award would be shared with Public Works staff at the cities of Fairview, Troutdale and Wood Village.

This is a technical assistance award providing professional services to the County. This would be part of current County Road Services staff's work program account for FY13 and included in Road Services Program Offer 91013.
