General Information

1. What action are you requesting from the Board?

NOND-08-17 is requesting approval to appropriate \$242,806 of one-time-only federal grant funding from the US Department of Housing and Urban Development (HUD) in partnership with the Violence Against Women Act (VAWA). Over three years, the Joint Office will be awarded a total of \$728,417 to provide housing assistance and support services to anyone who is HIV positive and whose housing stability is negatively impacted by sexual assault, domestic violence, dating violence and/or stalking.

2. Please provide sufficient background information for the Board and the public to understand this issue. Please note which Program Offer this action affects and how it impacts the results.

In Multnomah County, over 28,000 female residents are abused by an intimate partner each year, and over 21,000 of their children witness the abuse. While we don't have firm numbers on the portion of local domestic violence survivors who are HIV positive, national rates of HIV infection are twice as high among women who are domestic violence survivors. Compounding the problem, many people who experience domestic violence avoid getting tested for HIV and/or avoid telling their partner they're positive out of fear the partner will respond violently.

HUD has awarded the County \$728,417 over three years as part of their Violence Against Women (VAWA) and Housing Opportunities for Persons with AIDS (HOPWA) Project Demonstration Notice

of Funding Availability. Funding was competitively awarded by HUD to fund a specific new project, the Katie Project.

The Katie Project will help HIV-positive domestic violence survivors in Multnomah County connect with the housing and supportive services they need to live healthy and safe lives. The program will consist of support and housing services. Support services will include the trauma-informed and culturally-specific delivery of safety planning; crisis intervention; financial education, resources and planning; employment and education support; and physical and mental health engagement support. Housing Services will include navigation, eviction prevention, and financial supports to help participants access and maintain stable housing, including moving assistance, replacement of state identification, and flexible rent subsidies designed to help achieve financial stability and prepare for future rent burdens that come with housing independence.

The program anticipates serving 14 households per year and a minimum of 25 unduplicated households over the 3-year grant period to improve organizational and community services to people who are both HIV + and victims of Domestic Violence.

This funding supports Program Offer 10063A Supportive Housing

3. Explain the fiscal impact (current year and ongoing).

Approval of this budget modification will increase Multnomah County's federal/state FY 2017 budget by \$242,806. There is no increase to County General Fund expenses.

The Joint Office of Homeless Services Federal/State revenue budget will increase by \$242,806 in FY 2017 as a result of the work performed under this award. CFDA #14.241.

7. What budgets are increased/decreased?

Pass through payments will increase by \$237,326
Materials and supplies will increase by \$5,480

8. What do the changes accomplish?

In the short-term, the Katie project is expected to result in improved outcomes in housing stability, medical engagement, income attainment, violence reduction, and community engagement among project participants. Over the long-term, systems created through this demonstration project should positively impact all people seeking services in our community who are HIV+ and who have experienced domestic violence.

The project is a HUD demonstration project and identifies the funding as one-time-only. The Joint Office will continue to work with HUD to identify ongoing funding opportunities. If none are available, services will be restored to pre-award levels.

12. If a grant, what period does the grant cover? When the grant expires, what are funding plans? Are there any particular stipulations required by the grant (e.g. cash match, in kind match, reporting requirements, etc)?

The grant period is 2016-2019. There are no match requirements or non-standard reporting requirements.
