General Information

1. What action are you requesting from the Board?

Approval appointing the identified individuals on the attached list to the Sauvie Island/Multnomah Channel Rural Area Plan (RAP) and Transportation System Plan (TSP) Community Advisory Committee (CAC).

2. Please provide sufficient background information for the Board and the public to understand this issue. Please note which Program Offer this action affects and how it impacts the results.

The Sauvie Island/Multnomah Channel Rural Area Plan was first adopted In 1997 and the West Side Transportation System Plan in 1998. In response to the growing number of issues raised by community members and stakeholders in the planning area, staff, conducted a significant outreach and scoping effort that concluded in April 2013 to identify land use and transportation issues that should be addressed in an update to the RAP and TSP.

With support from the Board of County Commissioners, the County has committed to looking at the issues raised in the scoping report and addressing them in an update of the land use and transportation planning documents for the area.

The Community Advisory Committee is a group of individuals who have expressed interest in participating in the update. The following interest areas will be represented:

- Bicycle and pedestrian
- Floating home residents

- Moorages/Marinas
- Kennel Operator
- Farm stands/promotional activities
- Boating/River Recreation
- Natural Environment/Wildlife Habitat
- Agriculture-related uses, legislative history
- Sauvie Island Community Association (SICA)
- Large Scale Farming
- Seasonal Workers
- Hunters
- Business / Store Owner
- Columbia County Resident (non-voting - advisory role)

Additionally, a member of the Planning Commission from east County will be sitting in on the CAC meetings. Together with the Technical Advisory Committee (TAC), the CAC and the engaged public will help guide the update.

3. Explain the fiscal impact (current year and ongoing).

The FY 14 planning budget includes resources for staff and a consultant. Staff will manage the project and provide support to the CAC and the consultant.

4. Explain any legal and/or policy issues involved.

The CAC supports focused citizen/community involvement and will engage in a number of tasks including review of consistency with statewide planning goals and relevant case law. Additionally, a number of County initiatives are applicable including the Climate Action Plan, Health Equity Initiative, the Food Action Plan, the Equity and Diversity Lens, and the Natural Hazards Mitigation Plan.

5. Explain any citizen and/or other government participation that has or will take place.

Significant public outreach was conducted as part of the scoping process held this past Spring. This effort will continue to build on this to guide the process of updating the RAP and TSP. A robust public outreach effort will include involvement of both government and non-government stakeholders through both the Community Advisory Committee and Technical Advisory Committee, targeted outreach, open houses, and other community meetings.
