RESOLUTION NO. 03-026

Authorizing Private Sale of Certain Tax Foreclosed Property to LAMAR A JR & DONNA L DELANEY, Husband and Wife

The Multnomah County Board of Commissioners Finds:

- a) Multnomah County acquired the real property described below through foreclosure of liens for delinquent taxes.
- b) The property has an assessed value of \$00.00 on the County's current tax roll.
- c) Although no written confirmation from the City of Portland was obtained, the Tax Title Division is confident the shape, size, and location of the property, i.e. 2.4 inches x 107.25' containing approximately 21.45 square feet, make it unsuitable for construction or placement of a dwelling thereon under current zoning ordinances and building codes, as provided under ORS 275.225. The current zoning under which the property falls is R5a, Residential, one unit per 5,000 square feet
- d) LAMAR A JR & DONNA L DELANEY have agreed to pay \$150.00, an amount the Board finds to be a reasonable price for the property in conformity with ORS 275.225.

The Multnomah County Board of Commissioners Resolves:

1. Upon Tax Title's receipt of the payment of \$150.00, the Chair on behalf of Multnomah County, is authorized to execute a deed conveying to LAMAR A JR & DONNA L DELANEY the following real property:

The West 0.20 feet of the following:

All of Lots 13 and 14, Block 2 in MERRILL'S ADDITION and also a strip 14.85 feet in width west of and adjoining said Lots 13 and 14, Block 2, MERRILL'S ADDITION
