

Dear Ms. Wood Smith, Ms. Maurer and Mr. White:

Effective 5:00pm October 28, 2007, there is a vacancy in Senate District 14 due to the resignation of State Senator Ryan Deckert. The letter of resignation was received in our office on October 9, 2007. Since the letter of resignation was filed with a future date of October 28, 2007, we must allow three business days for the legislator to rescind his resignation. Therefore, the effective date is October 12, 2007.

Pursuant to ORS 171.060(1), you are hereby notified of the vacancy. ORS 171.051(2) requires each nominee to be a citizen qualified to hold the office, an elector of the 14<sup>th</sup> senate district and a member of the Democratic Party for 180 days prior to the date of the vacancy (5/1/07). In addition, Article IV, section 3 of the Oregon Constitution requires that the appointee shall have been an inhabitant of the district for at least one year prior to the date of the appointment. It is the responsibility of the Democratic Party to ensure that all nominees meet these qualifications before the submission of the "Willingness to Serve" statements to the Secretary of State.

You are advised the same statute requires the party central committees within the district to nominate no fewer than three nor more than five qualified persons to fill the vacancy. The nominating convention shall be conducted according to party rules.

**You are required by law to notify the Secretary of State of the persons nominated.** The nominations must be made no later than **November 17, 2007**, 20 days after the vacancy occurred.

The notification to the Secretary of State shall be accompanied by the signed written statement of each nominee indicating that the nominee is willing to serve in the office of State Senate District 14. Copies of the statement are enclosed (SEL Form 145a).



Subject to the time limits described above, the meeting of precinct committee persons may be scheduled and conducted according to party rules. Please notify this office of the date and time of the meeting when it is scheduled.

The Washington and Multnomah County Boards of Commissioners will meet to appoint one person from the list of three to five nominees submitted by the precinct committee persons. The vacancy must be filled by appointment not later than November 27, 2007, thirty days after the vacancy occurred.

problem was usually that the auditors moved too slow. The SmartMeters only give users eight seconds to pull back inserted credit cards before canceling the operation.

That small margin means that even auditors following precise, printed instructions for using the meters had a problem in one of every nine tries.

"Customers need to watch the meter's display screen carefully and to move fast to complete the transactions and obtain



receipts/stickers," the auditors wrote.

The city audit involved six people feeding more than \$100

into 77 meters around downtown Portland (57 smart ones and 20 of the old, dumb, coin-fed ones). Mostly, the audit

**Legislature** | Leaders will pick a hopeful to finish former state Sen. Ryan Deckert's term

Four people were chosen Monday night as candidates to replace former state Sen. Ryan Deckert, who left the Legislature to become president of the Oregon Business Association.

The candidates for Senate District 14 are Betty Bode, a Beaverton city councilor; Mike Bohan, an Aloha teacher; Mark Hass, a former Oregon House member; and Shantu Shah, a

previous candidate for public office. Hass was the top vote-getter among precinct committee members at the meeting.

Democrats from Washington County and one from Multnomah County gathered Monday in Aloha to select the candidates. Deckert's unexpired term runs

through 2008.

Senate District 14 covers parts of Beaverton, Aloha and Raleigh Hills.

By state law, the Democrats must choose three to five candidates, whose names are forwarded to the commissioners in Washington and Multnomah

counties. Commissioners from both counties choose Deckert's replacement, with their votes weighted by how many district Democrats live in each county.

As of Monday, there were 23,896 registered Democrats in the district in Washington County and 1,339 registered Democrats in the district in Multnomah County, according to elections officials.

Only Hass has announced plans to run for the seat in the 2008 primary, according to state elections officials. He previously served three terms in the House representing Raleigh Hills.



**Procedure for Conduct of Meeting to Fill Vacancy in Legislative Assembly**

The following procedures govern the conduct of a meeting of a county court or board of commissioners (hereafter, county governing body(ies)) to fill a vacancy in the Legislative Assembly. These meeting procedures apply to appointments made under either ORS 171.060(1) (vacancy to be filled by nominee affiliated with a major political party) or ORS 171.060(2) (vacancy need not be filled by member of a particular major political party).

(1) A meeting of the members of the county governing body(ies) shall convene at the time designated by the Secretary of State. If the legislative district includes more than one county, the Secretary of State shall also name the temporary chairperson for the meeting and designate its location, which shall be within the legislative district. The Secretary of State shall also notify the county governing body(ies) of the nominees and of the number of votes apportioned to each member of the county governing body(ies) under ORS 171.062 and 171.064.

(2) The chairperson conducting the meeting shall open the meeting at the time designated by the Secretary of State. The chairperson shall announce that the purpose of the meeting is to appoint a person to fill the vacancy in the Legislative Assembly. If applicable, the appointment will be made from the list of nominees from the major political party as furnished by the Secretary of State.

(3) Members of the county governing body eligible to vote on the selection are those physically or electronically present at the meeting, who are currently holding office by election or appointment.

(4) The county governing body(ies), in making its determination, may allot time for interviewing nominees or applicants and for other pertinent deliberations prior to voting.

(5) The vote shall be taken in a manner specified by a majority of those present and eligible to vote on the selection. The person receiving the highest number of votes shall be the appointee. However, in any case, the vote of each member of the governing body(ies) shall be recorded and included in the written statement required by ORS 171.060(3).

(6) The Secretary of State hereby adopts forms SEL 145a, Statement of Democratic Nominee's Willingness to Serve, and SEL 145b, Statement of Republican Nominee's Willingness to Serve, as the forms to be used to accept a nomination to fill a legislative vacancy.







# Why I am Running

By Mike Bohan

I have lived in Oregon long enough to watch control of the statehouse cycle from the Democrats to the Republicans and back again to the Democrats. These cycles represent shifting estimations by the electorate as to which party is best able to solve the problems facing the state. Invariably, optimism at the start of each cycle turns to pessimism at the end. Eventually, control reverts to the previous owners with the legislature often times no nearer to solving the state's long-term problems than before.

For example, consider the state's tax structure. Oregon's unique tax structure causes the state's income to fluctuate unpredictably. When times are flush, revenue forecasts trail actual receipts and the state finds itself with unanticipated monies that it must return in the form of kicker checks. When the economy starts to sour, revenue projections tend to over-estimate actual revenues and the state finds itself cutting back on programs just as the demand for those programs increases.

The need to create a permanent rainy day fund seems undeniable. Yet, over several decades, the legislature has been unable to create such a fund independent of which party controlled the statehouse.

Similar problems exist within our educational system – particularly higher education. The long-term economic viability of the state depends upon it having a well-educated workforce. Yet, over the past 25 years, we have decreased higher education support to such an extent that our best and brightest students often find it cheaper to matriculate out of state.

In a global economy, the need for an excellent university system seems obvious. Yet, today Oregon ranks 46<sup>th</sup> in state funding per student for post-secondary education. Not coincidentally, it ranks 46<sup>th</sup> in higher-education affordability. These statistics don't provide much basis for optimism that the state can create the type of educated workforce that will attract and retain future high-paying jobs.

A final example is Oregon's transportation infrastructure. We have the ninth most trade-dependent economy in the country. Still, funding for infrastructure has not kept pace with demand. Consequently, the state continues to fall further behind in upkeep of its roads and bridges. This has a real economic cost. For example, it is estimated that by the year 2025 traffic congestion will cost the state 16000 jobs and \$1.7 billion annually. One local example of congestion's impact: Intel has been forced to move its last shipment departure time up 2 hours because of increased evening congestion. For a global company like Intel, missed flights can severely affect operations as well as R & D.

While the importance of infrastructure to a healthy economy cannot be disputed, the legislature has been unable to come up with a funding mechanism that will allow the state to keep pace with its transportation needs.

Without realizing it, Oregon has been making a series of choices that will dramatically affect the quality of life of future generations. Every year that the legislature ignores these problems, they become more intractable. Oregon, once known as a state with innovative solutions to hard problems, today is just as likely to make the news for its short school year and congested roads.

People elected to the legislature often focus on finding quick solutions to pressing problems. As understandable as this is – after all, the next election is only two or 4 years away – it leads to the neglect of long-term issues. Over time, relatively small year-to-year declines can add up to produce major problems.

I am running for this position because I have the knowledge, skills, temperament and perspective to help solve some of these problems.

In my previous career as a systems engineer, I was often called upon to delve into the minutia of complicated systems without losing track of how all those parts and subsystems fit together to work as a whole. Too often, I see legislators investing inordinate amounts of time and energy on legislation that does little to solve the state's most pressing problems. I won't make that mistake.

My high-tech experience also helped me develop leadership and consensus-building skills. I often had responsibility for forming and directing cross-functional interdisciplinary teams. Obtaining consensus in groups composed of highly intelligent – but, headstrong -- engineers is a skill that will serve me well in Salem.

I am not just experienced in the impersonal world of high-tech, though. My experience as a teacher has helped me see the more human side of the state's successes and failures. I have gained a deep respect for the dedication of my teaching colleagues. Based on my personal observations, I am optimistic about the future of education in Washington County.

As a long-time political activist, I have forged working relationships with many state legislators and other office holders, allowing me to be able to hit the ground running if appointed. My contacts include not just Washington County legislators, but political leaders from across the state. In addition, my recent run for the legislature gives me a leg up on understanding many of the issues facing the legislature.

Finally, as a father I am deeply cognizant of the obligation my generation has to leave the world a better place for the next generation. From a selfish point of view, I don't want my son to have any reason to move out of the state when he's old enough to be on his own. I'd like to keep him as close as possible.

It is for these and many other reasons that I am running for this position. I look forward to meeting with you on Tuesday and answering any questions you might have.



## **Legislative Accomplishments**

### **2001**

HB2421 Signed into law by John Kitzhaber; this measure offers tax incentives for businesses that provide college scholarship programs for their employees. It is administered by the Oregon Student Assistance Commission, where it is known as the "Hass Scholarship Law."

### **2001**

HB3300(Co-sponsor) Signed into law by John Kitzhaber; the referenced based formulary drug bill, as it was known, sought to reduce costs for the Oregon Health Plan. As a co-sponsor, Mark helped shepherd it through his committees and into state law. It has saved millions in prescription drug costs for Oregon taxpayers.

### **2003**

HB2449 Signed into law by Ted Kulongoski; protections for Oregon seniors are stronger today because of this law which raised the penalties for those who prey on elders. The law was prompted by Washington County attorneys who needed more tools to protect seniors in our community. The measure also tripled civil damages that may be sought against unscrupulous insurance vendors and others who victimize senior citizens.

### **2005**

HB2415 Signed into law by Ted Kulongoski; another elder abuse law, this one prohibits abusers from sharing inheritance proceeds from their victims. It stems from a disturbing elder abuse case in the Garden Home neighborhood.

### **2005**

HB3449 Signed into law by Ted Kulongoski; Automatic External Defibrillators (AEDs) have been saving lives for years. But until last year, they were not available in Oregon schools or in most public buildings. This legislation removes liability issues and opens the school doors so that they can be used to prevent tragedies like the 2001 heart event that took the life of seven year old Graeme Jones of Beaverton.

## **Unfinished Business**

### **Transportation**

Oregon's gasoline tax has increased since 1993, even with a 40 percent jump in population during that time. This has left our counties scrambling to deal with growth and meet their own economic goals. He is hoping the SB 566 study passed in 2007 will set the stage for a major statewide transportation package. This package should include identifiable deliverables so that the public understands what it is buying. It should also include an economic filter to evaluate return on investment.

### **Tax Reform**

No other state is as dependent on one single tax as Oregon is with its income tax. Oregon brings in too much money in the good times and not enough in the bad times. It's in the bad times that our state has a train wreck. Mark served during those times and it is what drives him to change the system in a way that reinstates fairness and stability to our tax code.

### **Willamette River Clean up**

Mark teamed with former legislator Charlie Ringo in 2003 and 2005 to sponsor legislation a series of pollution clean-up efforts for the Willamette. The biggest challenge seems to about funding the Department of Environmental Quality so that its own rules are enforced. One way to attack pollution in the Willamette is to uniformly clean up basins that drain into it, including the Tualatin River.

# Hass is Democrats' pick to replace Deckert

## If selected, the ex-lawmaker wants to work on tax reform and transportation funding

Democrats from Washington County -- and one from Multnomah County - have chosen former legislator Mark Hass as their clear preference to replace state Sen. Ryan Deckert.

More than 50 precinct committee members gathered Monday night in Aloha and gave Hass 12,905 votes; Mike Bohan, an Aloha teacher, 6,746 votes; Betty Bode, a Beaverton city councilor, 4,662 votes; and Shantu Shah, a previous candidate for public office, 839 votes.

Hass, 50, served three terms in the House representing Raleigh Hills. Besides possibly finishing Deckert's term, Hass has officially filed to run for the District 14 seat in the 2008 primary.

He said he wants to get back to work on tax reform, transportation funding and cleaning up the Willamette River.

"Those three issues constitute unfinished business in my eyes and that's why I'm running," he said.

By state law, when a legislator leaves midterm, the party must choose three to five candidates. The names are forwarded to the county commissioners in the affected district. Commissioners from Washington and Multnomah counties will choose Deckert's replacement, with their votes weighted by the number of district Democrats in each county.

The commissioners expect to make their pick in late November, said Philip Bransford, a Washington County spokesman. Despite the support for Hass, other members of the slate said Tuesday they haven't ruled out running in the 2008 primary if they aren't chosen by the commissioners.

"Still looking at that, yeah," said Bode, 60, who was first elected to the Beaverton City Council in 2002 and re-elected in November 2006.

"Possibly," said Shah, 66, a retired electrical engineer who lives in Raleigh Hills. He has run multiple times for public office, including challenging U.S. Rep. David Wu in 2006.

Bohan, 55, of Beaverton said he probably would not run. "I don't believe in challenging a sitting Democrat unless there's some overwhelming

reason," he said. A former systems engineer, he now teaches math at Aloha High School. Former chairman of the Washington County Democrats and current chairman of the 1st Congressional District Democrats, Bohan ran unsuccessfully for state representative in 1990 and 2006.

Senate District 14 covers parts of Beaverton, Aloha and Raleigh Hills. As of Monday, there were 23,896 registered Democrats in the district in Washington County and 1,339 registered Democrats in the district in Multnomah County.

Deckert left his Senate seat this fall to become president of the Oregon Business Association.

Although the Democrats had to endorse a slate, it's not surprising they marked Hass as their clear favorite, said Jim Moore, a political science instructor at Pacific University in Forest Grove. Hass has the political experience, has filed to run and can cash in on his name and face recognition from his days as a TV newsman, Moore said.

Of course, the commissioners could do something completely unexpected, he said.

"It's now totally up to the commissioners," Moore said. "They could pick anybody. They could reject the entire slate."

## Why save? There's not a drop of rain in sight

While other states are rebuilding their rainy-day funds, Oregon is preparing to kick back a record \$1.3 billion

Mark Hass, a Beaverton Democrat who will leave the Legislature at year's end, served through good times and the five special sessions when Oregon's tax revenue collapsed and it became the only state in the nation to shut down many of its schools early.

In his last meeting in the Capitol on Thursday, Hass listened as state economists described how tax revenues are flooding into the state, but that the only-in-Oregon kicker law requires the state to send a record \$1.3 billion rebate to corporate and personal taxpayers. As it stands, Oregon won't save a dime of the money.

When Hass finally spoke, he described a farmer who never gets around to fixing the leaky roof in his barn. "He can't fix it in the winter because it's raining," Hass said. "And he doesn't fix it in the summer because it's not leaking."

Oregon is that farmer.

It never seems to be the right time to begin building the rainy-day fund that is desperately needed in a state with the nation's most volatile system of public finance. It is never the right time to truly confront the state's over-reliance on income and capital gains taxes, which deter investment. It is never the right time to lead the way and persuade Oregonians to change their dumb and damaging kicker law.

What is Oregon waiting for? It's seen rain. It was only five years ago that this state watched its revenue collapse faster and deeper than any other state. It was Oregon that became known far and wide as a place that couldn't keep its schools open, or provide life-and-death medications to its poorest citizens, even during what was widely considered to be a mild recession.

Now, of course, there's not a cloud in the sky. What, Oregon worry? Instead of building a rainy-day fund with the revenue that has poured into state coffers, its kicker law requires the state to send personal taxpayers more than \$1 billion next year, and give mostly out-of-state corporations a 61 percent tax cut, to the tune of \$238 million. No state has ever given back more tax money in a single rebate.

That makes no fiscal sense. None. Look around. Every other state in the union is using these good times to sock away money in rainy-day funds or make investments that will strengthen their education systems and better position them when the economy slumps again.

But not this one. Not the very state with the most volatile tax system, the one that closed its schools, kicked tens of thousands off its health plan and laid off so many of its state police that a moviemaker decided that this was the place to come to mock the lack of homeland security on the West Coast.

On Thursday, more than a dozen lawmakers sat at a meeting of the House and Senate revenue committees to hear the latest economic forecast, and see that the expected kickers had ballooned to \$1.3 billion. Hass, the departing lawmaker, was the only one who said out loud that the money should instead be saved in a rainy-day fund.

There is a huge failure of leadership in Oregon on this issue, from Gov. Ted Kulongoski on down. Kulongoski once proposed suspending the personal kicker for several years and building a rainy-day fund, but he's since run from that idea. His Republican opponent, Ron Saxton, says he supports a rainy-day fund and is open to changing the corporate kicker, but wants to use it as a bargaining chip and trade it for cuts in capital gains or estate taxes.

In fact, neither of them has the courage to look Oregonians in the eye and tell them that next year they can have \$1.3 billion in kicker checks, or a substantial rainy-day fund, but not both.

Instead, we keep hearing them and other elected officials and candidates pledge to have a "conversation" with voters and corporate leaders about the kicker. That has become one of the lamest and most meaningless positions in Oregon politics.

These "conversations" never go anywhere. Our leaky roof never gets fixed.

Now it's an election year.

And, of course, there's not a cloud in the Oregon sky.

**The Multnomah County Board of Commissioners Finds:**

- a. Effective October 28, 2007, there is a vacancy in Oregon State Senate, District 14, due to the resignation of State Senator Ryan Deckert.
- b. Pursuant to state law, on October 29, 2007, the Democratic Party Precinct Committeepersons of Senate District 14 met to choose nominees to fill the vacancy.
- c. The nominees chosen were: Elizabeth Ann Bode, Mike Bohan, Mark Hass and Shantu Shah.
- d. In accordance with procedures established by the Secretary of State, the Washington and Multnomah County Board of Commissioners considered the nominations at a joint public meeting at 1:00 p.m. on Tuesday, November 20, 2007.
- e. In accordance with ORS 171.062 each County is entitled to one vote for each 1,000 registered electors or major fraction of 1,000 (more than 500 registered electors, but less than 1,000) within Oregon State Senate District 14; and each County Commissioner is allotted the following number of votes:

Washington County: 60,685 or 61 votes divided by 5 = 12-1/5 votes per Commissioner  
Multnomah County: 2,855 or 3 votes divided by 5 = 3/5 vote per Commissioner

- f. At the conclusion of the public meeting the Commissioners voted to appoint Mark Hass to fill the vacancy, said nominee having received the highest number of votes as indicated on the vote tabulation attached as **Exhibit A**.

**The Multnomah County Board of Commissioners Resolves:**

1. Mark Hass is selected as the appointee to fill the vacancy in the Legislative Assembly, Oregon State Senate District 14.

2. This Resolution shall promptly be forwarded to the Secretary of State as required by ORS 171.060(3).
