Updating the WIC Food Package

Fruits, vegetables and whole grains were added to the list of WIC authorized foods for the first time in the program's history. These healthy changes align with the 2005 Dietary Guidelines for Americans and the infant feeding practice guidelines from the American Academy of Pediatrics.

Other positive changes implemented in August 2009 include:

- Lower fat milk for adults and children 2 and older,
- Soy beverage alternatives for participants who cannot tolerate cow's milk, and
- Baby food fruits and vegetables instead of juice for infants.
