### 1. What action are you requesting from the Board?

The Department of County Assets requests Board approval of budget modification DCA-26-17, reclassifying position 705385 from Project Manager (NR) (9063) to Manager 1 (9615), effective August 2016 in program offer 78200-17 (Facilities Director's Office).

### 2. Please provide sufficient background information for the Board and the public to understand this issue. Please note which Program Offer this action affects and how it impacts the results.

This modification affects program offer 78200-17 (Facilities Director's Office). This management-initiated request in the Department of County Assets' Facilities & Property Management division is for reclassification of a filled position from a Project Manager (NR) to a Manager 1 as a result of a gradual change in duties and responsibilities since August 2016. This position is responsible for division wide performance management, project management process improvement, business planning, budgeting and staffing recommendations. An analysis of the Project Manager (NR), Manager 1, and Manager 2 classifications was performed before making an allocation decision and the Manager 1 position was determined to be the best fit due the scope and level of responsibilities.

### 3. Explain the fiscal impact (current year and ongoing).

This reclassification results in a personnel cost decrease of \$760 in the current fiscal year, which is offset in Professional Services expense. In subsequent years the reclassified position will be

subject to the approved cost of living adjustments and step increases.
