Subject: Tobacco retail licensure

Good Afternoon Chair Kafoury and Commissioners Bailey, Smith, Shiprack and McKeel:

I am Luci Longoria, and I am here today representing the Oregon Public Health Division. I am the Health Promotion Manager for the Health Promotion and Chronic Disease Prevention Section the Public Health Division, where our mission is to promote health and prevent the leading causes of death, disease and injury in Oregon. The leading cause of preventable death and disability in Oregon is tobacco use, and as the manager for the Tobacco Prevention and Education Program, I am delighted to be here today as you consider options for protecting Multnomah County residents from tobacco through retail licensing.

Oregon's Tobacco Prevention and Education Program works in partnership with local public health authorities, tribes, and community-based organizations; with public, private and non-profit partners to engage communities in promoting smokefree environments and reducing the influence of tobacco marketing on the most vulnerable among us, particularly kids. We also help the three quarters of Oregon smokers who want to quit, be most successful at quitting and staying quit. It's a great privilege to work in partnership with the experts in the Tobacco Prevention and Education Program at Multnomah County Health Department. We have a long history of working together on meaningful tobacco control strategies based in science that get results.

The Public Health Division commends Multnomah County's leadership in exploring options that can address tobacco and e-cigarettes in retail settings. Strong, science-

informed policies that work in local communities are critical to shaping meaningful and effective statewide policies that address health equity.

Addiction to tobacco starts in adolescence; in fact, nine of ten adults who smoke report that they started smoking before turning 18. Why is this? As noted in the Surgeon General's Report, "*...promotion and advertising by the tobacco industry causes tobacco use including its initiation among youth.*"

Kids in Oregon are under constant pressure to start using tobacco. Tobacco is cheap, readily available and easy to get, and it's heavily promoted and marketed in stores where kids frequent and hang out. The tobacco industry has shifted from billboards and sporting events and T.V. commercials, to dominating the retail environment with their eye-catching products. In fact, the tobacco industry is spending \$1 million an hour on advertising and promotion in retail stores. Tobacco products come in every size, shape, color, flavor, and price -- often displayed at young kids' eye level (three feet or lower), right near the candy.

And it's working. Seven out of ten Oregon 11<sup>th</sup> grade students and six out of ten 8<sup>th</sup> grade students recall seeing an advertisement for tobacco products on a storefront or inside a store (2013). Youth who live or go to school in neighborhoods with the highest density of tobacco outlets or retail advertising have higher smoking rates compared to youth in neighborhoods with fewer tobacco outlets. While consumption of cigarettes has decreased among Oregon teens, use of flavored little cigars and e-cigarettes has remained steady or increased -- in fact, its use is twice that of cigarettes (18 percent use non-cigarette tobacco products; 9 percent smoke cigarettes).

Retail tobacco licensing is a tool to implement and enforce a package of innovative policies that will reduce the number of Multnomah County youth that become addicted to tobacco. Communities that have put in place meaningful retail restrictions through licensure have some of the lowest tobacco use rates in the country. A licensing package can include policy options such as a ban on flavors, on free samples, on the sale of single use products and on the redemption of coupons and multi-pack offers. Applications for new licenses could be prohibited for stores near schools, child care centers, or where there are already other tobacco retailers. Pharmacies could be prohibited from selling tobacco.

Please keep in mind, however, that policy approaches that only restrict youth access or that punish youth for getting or having tobacco have not proven effective. In Utah, for example, where smoking rates are low and age restrictions for e-cigarettes have been in place since 2010, e-cigarette use among youth continues to rise.

**We know that when it is sweet, cheap and available kids use tobacco. A licensing package can regulate the density of tobacco retailers around schools and child care centers, ban flavored products and limit price discounts.**

Good afternoon, my name is Dr. Tia Henderson, the Research Manager at Upstream Public Health, a statewide nonprofit focused on improving the health of all Oregonians through sound policy. I want to commend the Commissioners for considering protecting our children's health through reduced access to nicotine products. As a Portland resident, I appreciate the government taking this proactive role in looking after community wellbeing.

The set of tobacco policies you are considering today will help protect our community's current and future health. Tobacco-related illness robs us of our loved ones and steals our youth's health when they become addicted to nicotine at an early age. I have friends who began using tobacco chew in middle school and have tried countless efforts to stop without success. I participated in the recent tobacco retail assessment with the Oregon Health Equity Alliance and the Multnomah County Health Department and I was troubled by the focus of many nicotine products focus on children. I don't know a child who can resist a name like "silly strawberry." Every 3<sup>rd</sup> High School junior you meet today in Oregon has used some form of smokeless tobacco products according to a recent Healthy Teens Survey. It's no wonder then that tobacco-related illness continues to be the number one killer in Oregon. I am also troubled by recent research that indicates nicotine is exhaled by users of e-cigarettes and can be absorbed second hand by youth. As of today, I can inhale from this e-cigarette, exhale nicotine into the air that affects my peers sitting nearby, and I can legally sell one to a five year old.

We have a shared responsibility to consider prevention-focused policies including a licensing system, regulating e-cigarettes so that minors cannot purchase them, and include e-cigarettes in the Indoor Clean Air Act. I urge you to take these common sense actions to protect our youth's health now and in the future.
