CHAIR LINN THANKED EVERYONE FOR BEING HERE. CHAIR LINN APOLOGIZED FOR NOT

BEING MORE OPEN ABOUT THE SAME SEX MARRIAGE PROCESS AND APOLOGIZED TO THE CITY OF GRESHAM AND TO COMMISSIONER ROBERTS FOR THE WAY SHE TREATED HIM AND ADVISED SHE IS VERY PROUD OF THE MARRIAGES OF 3,000 COUPLES IN MULTNOMAH COUNTY. CHAIR LINN APOLOGIZED FOR THE NEW DIRECTOR SALARY AND SNOW DAY EMPLOYEE PAYMENT ISSUES.

CHAIR LINN PRESENTED HER EXECUTIVE BUDGET MESSAGE, ADVISING SHE LEFT FLEXIBILITIES FOR FINAL DECISIONS AND SPOKE IN SUPPORT OF FUNDING FOR SUN SCHOOLS AND PUBLIC SAFETY PROGRAMS. CHAIR LINN ACKNOWLEDGED AND APPRECIATED THE EFFORTS OF COMMISSIONERS NAITO, CRUZ, ROBERTS AND ROJO, THE BUDGET OFFICE, DEPARTMENT DIRECTORS AND STAFF, THE SHERIFF, AUDITOR AND DISTRICT ATTORNEY.

COMMISSIONER NAITO MOVED AND COMMISSIONER CRUZ SECONDED, APPROVAL OF R-1. KARYNE DARGAN EXPLANATION AND CLARIFICATION IN RESPONSE TO A QUESTION OF COMMISSIONER ROBERTS. Commissioner Roberts returned at 10:26 a.m.

GARY CLIFFORD EXPLANATION OF ALL FIVE ORDINANCES (R-10 THROUGH R-14). PHILIP THOMPSON TESTIMONY ADVISING HE IS IN SUPPORT OF THE ALL THE ORDINANCE CHANGES EXCEPT THE PLANNING COMMISSION NOT CHANGING THE DWELLING TEMPLATE TEST IN CODE CHAPTERS 33 AND 36 FROM "LAWFULLY CREATED" TO "LAWFULLY EXISTED" IN CONFORMANCE WITH STATE LAW. IN RESPONSE TO A QUESTION OF COMMISSIONER NAITO, MR. CLIFFORD ADVISED

THE PLANNING COMMISSION ADDED THE TERM "LAWFULLY CREATED" TO THE COUNTY CODE IN 1996. COMMISSIONER NAITO REQUESTED THAT THE PLANNING COMMISSION BE ASKED TO REVIEW ITS POLICY AND ADDRESS THIS ISSUE SEPARATELY SO THESE ORDINANCES CAN MOVE FORWARD. COMMISSIONERS ROBERTS AND ROJO STATED THEY SUPPORT THAT SOLUTION AND WILL JOIN COMMISSIONER NAITO IN WRITING A LETTER TO THE PLANNING COMMISSION. IN RESPONSE TO A QUESTION OF COMMISSIONER ROJO, MR. CLIFFORD ADVISED THAT COUNTY CODE CAN BE MORE RESTRICTIVE THAN STATE LAW. IN RESPONSE TO A QUESTION OF COMMISSIONER NAITO, MR. CLIFFORD ADVISED THERE ARE SOME ILLEGAL MOBILE HOMES IN RURAL AREAS. CHAIR LINN ADVISED SHE AGREES TO ASK THE PLANNING COMMISSION TO REVIEW THIS POLICY AND COMMISSIONER NAITO ASKED MR. CLIFFORD TO PREPARE A DRAFT FOR THE BOARD. CONSTANCE KREITZ TESTIMONY ADVISING SHE PURCHASED HER PROPERTY 30 YEARS AGO, HAS HAD THREE ADDRESS CHANGES IN THAT TIME AND THAT SHE HAS NOW BEEN TOLD HER LOG HOME IS ILLEGAL AND SHE CAN'T SELL IT. STAFF DIRECTED TO LOOK INTO THE ISSUE AND REPORT BACK TO MS. KREITZ AND THE BOARD.

Chair Linn was excused at 10:40 a.m.

COMMISSIONER NAITO MOVED AND COMMISSIONER ROJO SECONDED, APPROVAL OF R-10, R-11, R-12, R-13 AND R-14. DON STURM TESTIMONY RELATING TO PROPOSED CODE AMENDMENTS TO CHAPTER 35, EXPLAINING HE IS A CORBETT FARMER AND WANTS TO BUILD ON HIS PROPERTY SO HE CAN LIVE WHERE HE WORKS, BUT BECAUSE HE HAS A RESIDENCE IN TROUTDALE, OREGON LAW PREVENTS HIM FROM BUILDING IN CORBETT. IN RESPONSE TO A QUESTION OF COMMISSIONER ROBERTS, MR.

STURM ADVISED HE HAS A HOUSE WITH EIGHT ACRES OF NURSERY STOCK AND WANTS TO MOVE TO HIS MAIN FARM 13 MILES AWAY. IN RESPONSE TO A QUESTION, MR. CLIFFORD ADVISED HE IS NOT FAMILIAR WITH THE SPECIFICS. COMMISSIONER CRUZ SUGGESTED THAT SINCE MR. STURM'S ISSUE DOESN'T EXACTLY RELATE TO THIS LEGISLATION, MR. STURM WORK WITH LAND USE PLANNING STAFF. THE FIRST READINGS OF ORDINANCES R-10 THROUGH R-14 WERE APPROVED, WITH COMMISSIONERS NAITO, CRUZ, ROBERTS AND ROJO VOTING AYE. SECOND READINGS THURSDAY, MAY 13, 2004.

- R-15 First Reading of an ORDINANCE Amending MCC Chapter 34, Land Use Code, Sauvie Island/Multnomah Channel Rural Plan Area, to Add Certain Transportation Land Uses, Add a Definition of "Water-Dependent Use", and Amend the Definition of "Large Fill"

ORDINANCE READ BY TITLE ONLY. COPIES AVAILABLE. COMMISSIONER ROJO MOVED AND COMMISSIONER ROBERTS SECONDED, APPROVAL OF FIRST READING.

Commissioner Naito was excused at 10:48 a.m. and returned at 10:50 a.m.

GARY CLIFFORD EXPLANATION. NO ONE WISHED TO TESTIFY. FIRST READING APPROVED, WITH COMMISSIONERS CRUZ, ROBERTS AND ROJO VOTING AYE, AND COMMISSIONER NAITO VOTING AYE AS SHE RETURNED TO THE DAIS. SECOND READING THURSDAY, MAY 13, 2004.

- R-16 First Reading and Possible Adoption of an ORDINANCE Amending MCC Land Use Chapters 33 through 38 with Respect to Violations and Enforcement, and Declaring an Emergency

ORDINANCE READ BY TITLE ONLY. COPIES AVAILABLE. COMMISSIONER ROBERTS MOVED AND COMMISSIONER ROJO SECONDED, APPROVAL OF FIRST READING AND ADOPTION.

KIM PEOPLES EXPLANATION OF PLANS TO ENFORCE VIOLATIONS AND TO ADDRESS BACKLOG OF COMPLAINT CASES NOT YET INVESTIGATED. BOB LEIPPER TESTIMONY REQUESTING MANDATORY FINANCIAL PENALTIES FOR CODE VIOLATIONS, WITH FUNDS COLLECTED AND USED SUCH AS WILL BE DONE WITH ITAX MONIES. MR. LEIPPER EXPLAINED THAT CODE VIOLATIONS ARE NO LONGER REQUIRED TO BE RECORDED IN DEED RECORDS, PUTTING UNSUSPECTING BUYERS IN JEOPARDY OF POTENTIAL VIOLATIONS OF THE COLUMBIA GORGE NATIONAL SCENIC ACT. IN RESPONSE TO A QUESTION OF COMMISSIONER ROBERTS, MR. PEOPLES ADVISED THAT PRIOR LAND USE PLANNING PRACTICE WAS NOT TO ASSESS A PENALTY, TO JUST INFORM PROPERTY OWNERS OF THE VIOLATION AND GIVE THEM TIME TO ADDRESS THE VIOLATION. ORDINANCE 1032 ADOPTED, WITH COMMISSIONERS NAITO, CRUZ, ROBERTS AND ROJO VOTING AYE.
