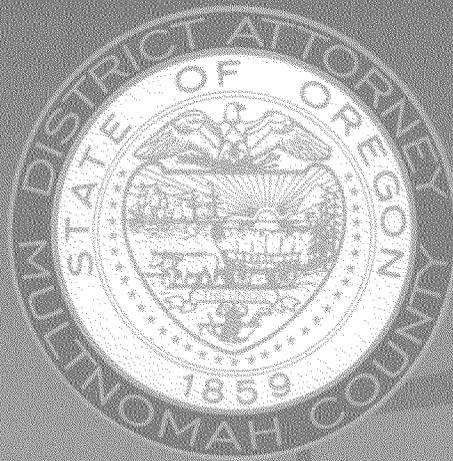

# District Attorney's Office Services

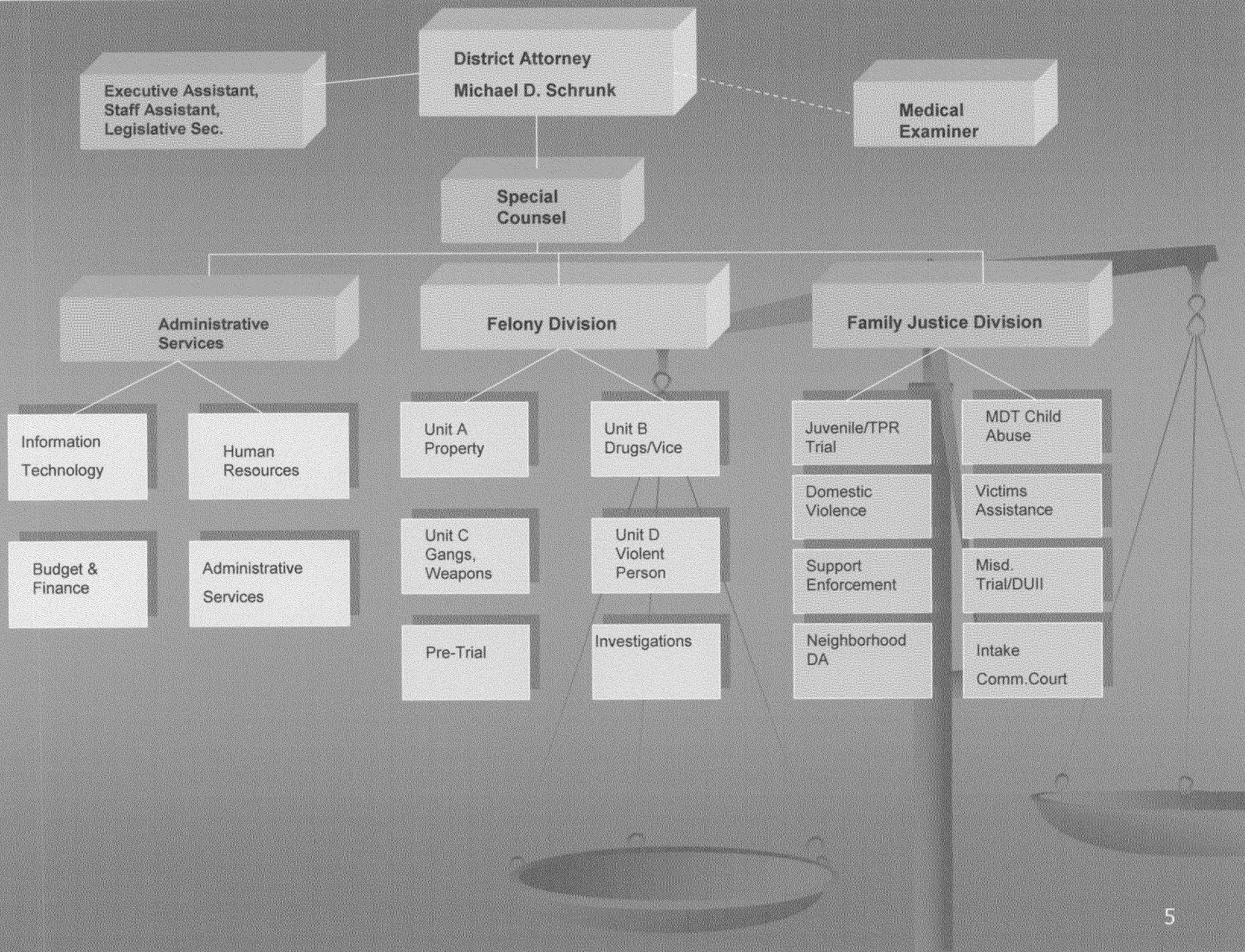
- The District Attorney's office reviews and prosecutes criminal cases presented by seven police agencies within the county; represents the State in cases of juvenile dependency and delinquency; enforces child support orders; and provides services to victims.
- The office works in collaborative partnership with other public safety and social service organizations to prevent and intervene in domestic violence, elder abuse, child abuse, and to eliminate chronic sources of crime through appropriate sanctions, supervision and treatment programs.
- Felony and misdemeanor units, programs that specialize in prosecuting specific crimes and support services for victims, enable the office to respond effectively to community safety issues and victims of crime.

# DISTRICT ATTORNEY'S OFFICE

- The District Attorney's Office works collaboratively and cooperatively with its public safety partners to maintain a balanced, fair and effective system, based on the *stream of offenders* strategy, that protects the citizens of Multnomah County and reduces the crime rate.
- Holding offenders accountable, protecting children, bringing a sense of justice to the victims of crime and innovative programs like *Community Court* and the *Neighborhood DA* that reach out and engage citizens in the development of crime prevention and protection strategies are the core themes that run throughout the program offers submitted by the District Attorney's Office.

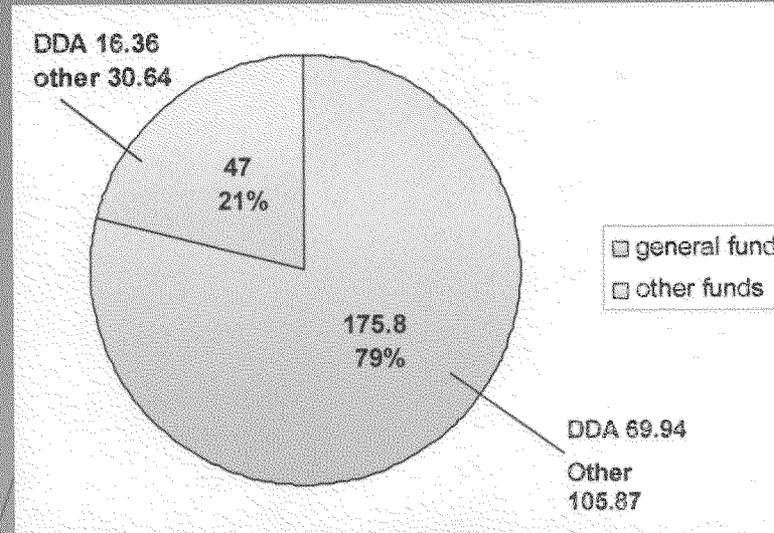
## FISCAL YEAR 2008 CASE ACCOMPLISHMENTS

- Felony trial units – 7806 cases reviewed
  - The Property Crime unit – 2159 cases reviewed

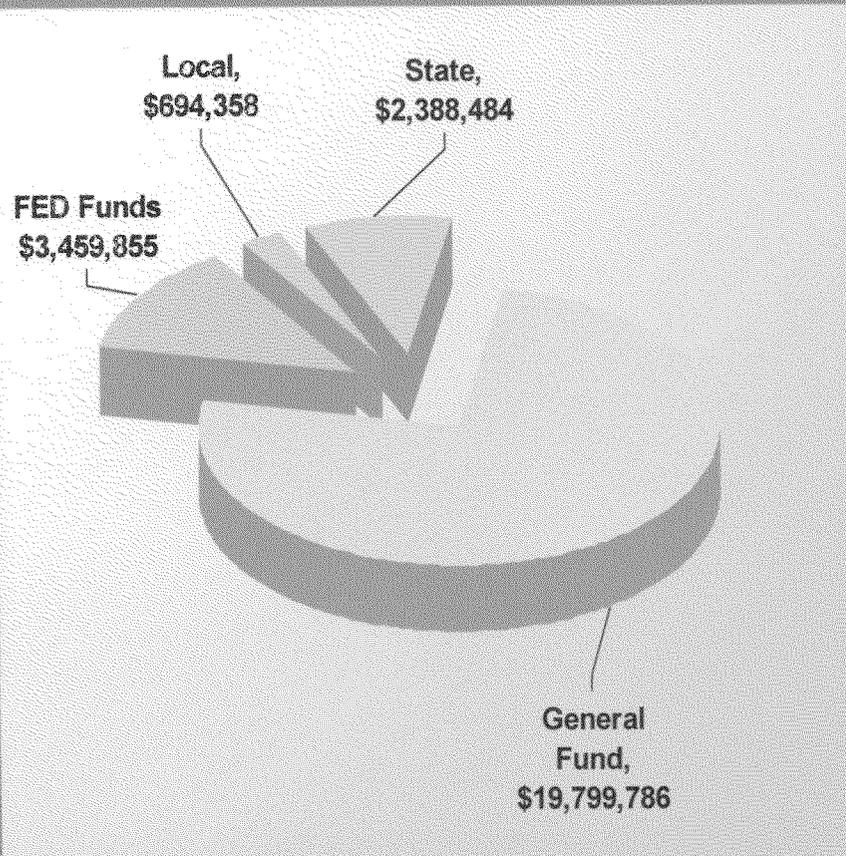

# DISTRICT ATTORNEY BUDGET FY09 Funding \$26,342,483

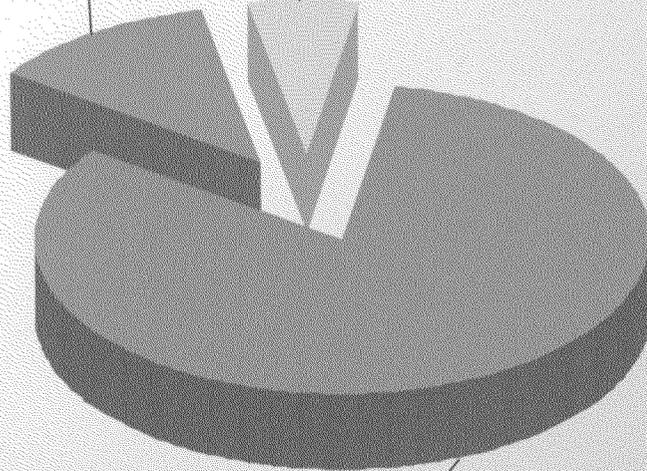

# District Attorney Budget Cost Breakdown Total \$26,342,483



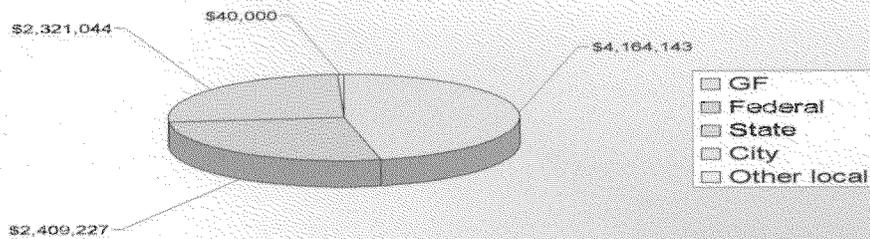

# FY09 Funding Streams by Fund Center

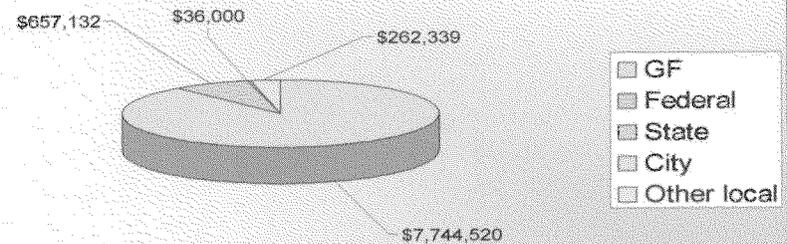


# FY09 Funding streams by fund Center

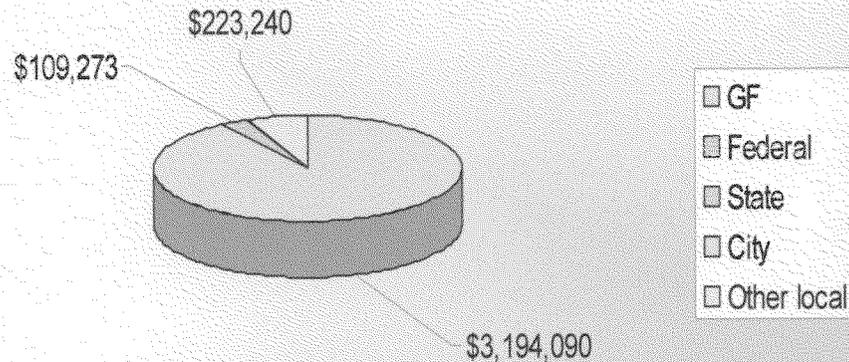
**Family Justice 15-30**

# Federal/State Impacts

## Federal Revenue

- **Federal grant opportunities**

Grant funding and opportunities continue to dry up at the federal level. Justice Assistance Grants (JAG) and Project Safe Neighborhoods grants (PSN) had 75% reductions.

- **Stomp Out Meth Project**

Multnomah County's received a Congressional earmark for this program and did not ask for an additional Federal Appropriations request.

## State Revenue

- In 2007/2008 \$235K in State general fund backfilled a loss of federal match dollars in the Child Support Program and made this funding available again in 2008/2009.

- The State Department of Justice has provided funding for Juvenile Dependency for the current biennium. The \$377K supports a Deputy DA and Clerical position for the two year period.

# Current Year Workforce Reductions

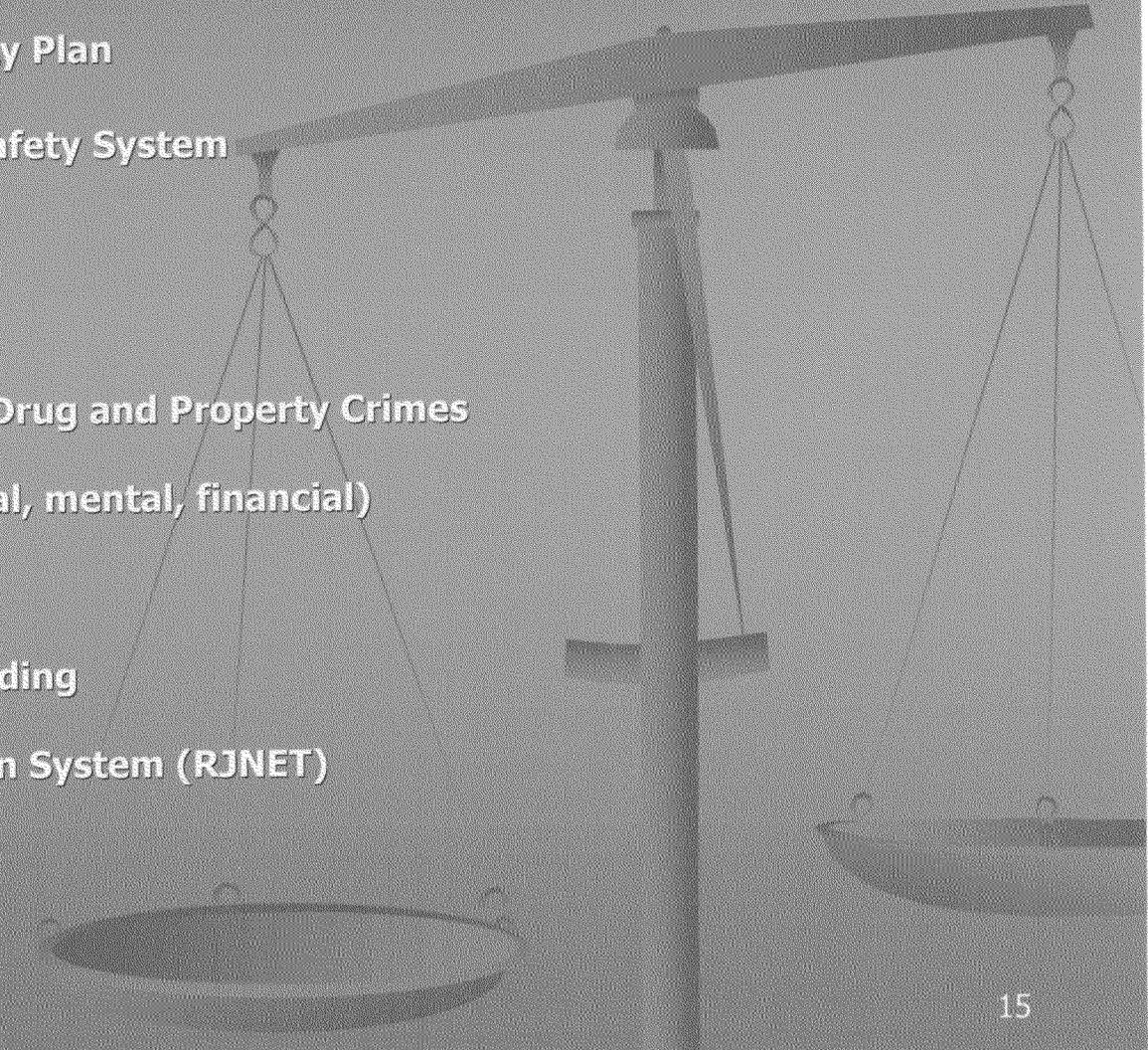
## Positions lost

- **The loss of two net Deputy DA positions during the 2008/2009 budget process. ( Juvenile DDA 2, Gresham Neighborhood DA2)**
- **2.5 additional Deputy DA positions lost this fall due to grant funding that was not renewed. (Drug Unit B DDA, Domestic Violence DDA, .5 DDA Unit A property crimes)**

## Impacts to Services

- **Loss of Justice Assistance Grant Revenue reduced prosecution in Drug Unit, Property Crime and Domestic Violence units.**
- **Neighborhood DA- 2,000 fewer contacts with citizens, business leaders and law enforcement in East County.**
- **Juvenile Deputy- Less involvement in Juvenile case planning conferences, longer time frame for legal sufficiency reviews and less interaction with families and the community.**
- **Staff and Deputy DA's recalled from Domestic Violence and cold case cooperative programs to cover.**

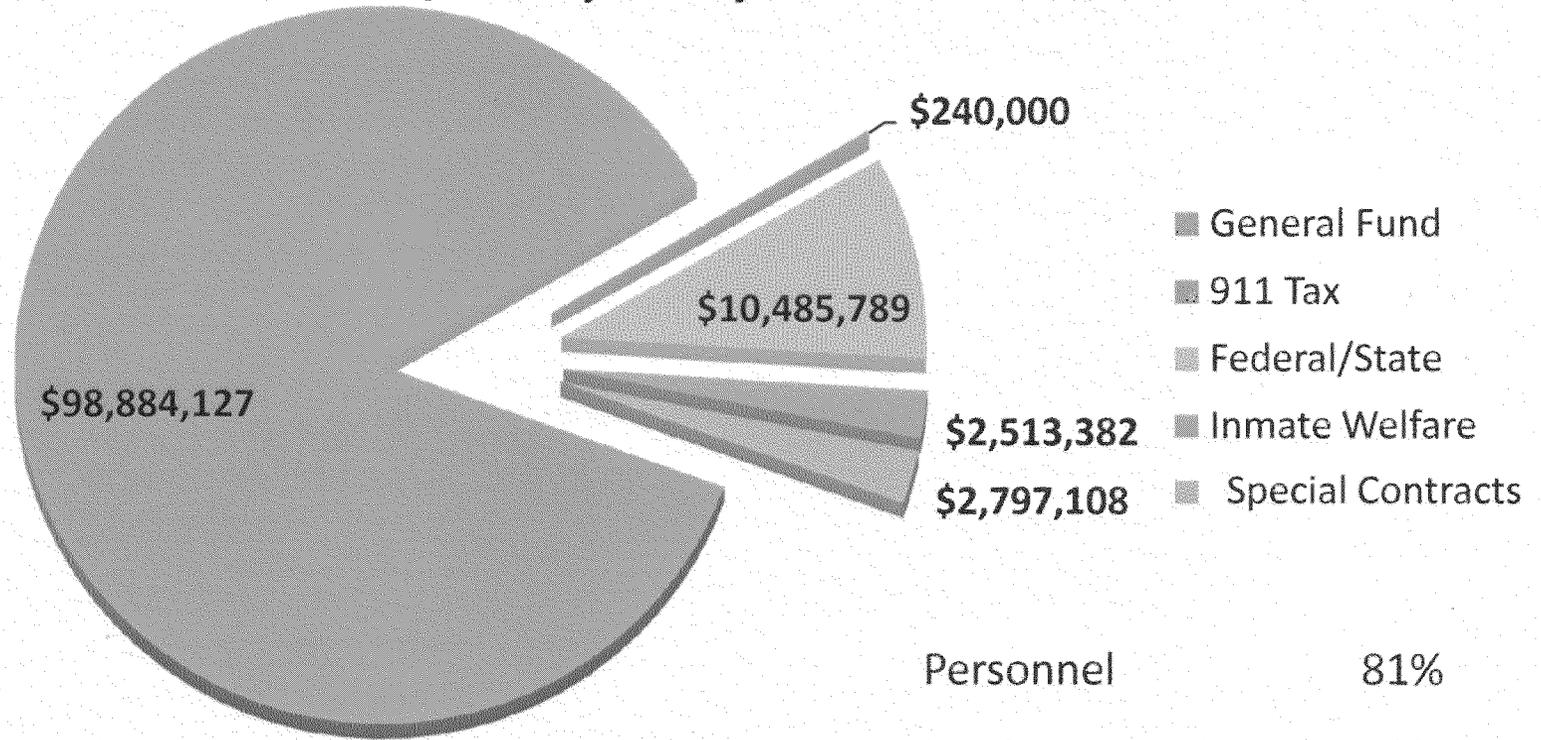

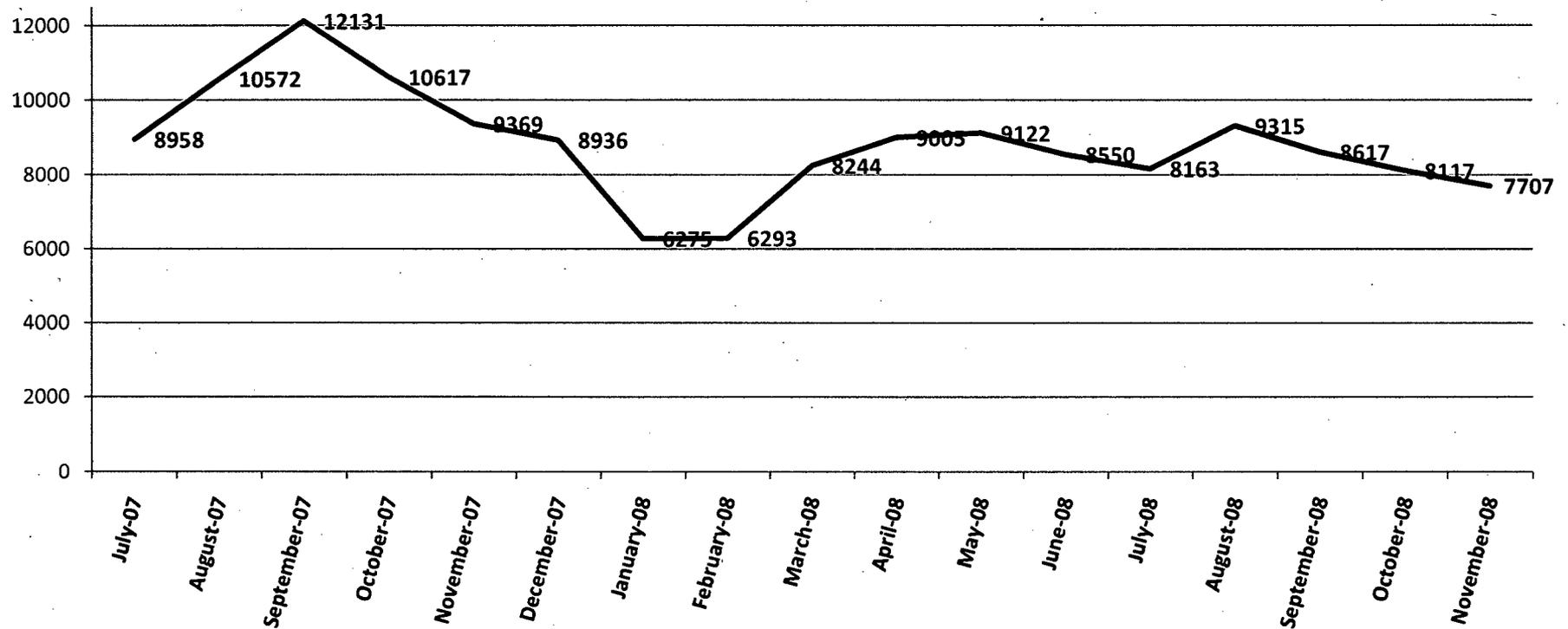

# Current Year Program Impacts

- Budgeted capacity to support 1,539 beds, a reduction of 94 beds from FY 2008.
- Of the 1,539 beds, 126 are funded for seven months pending a decision to continue funding at MCDC or open the Wapato Jail.
- Four Deputy Sheriff's reduced from Civil Process Unit
- Two Deputy Sheriff's added to Warrant Service Unit
- One Deputy Sheriff added as Corbett Community Services Officer.

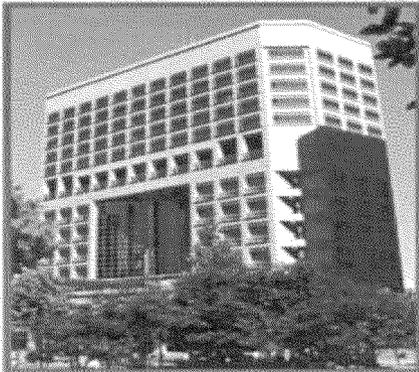

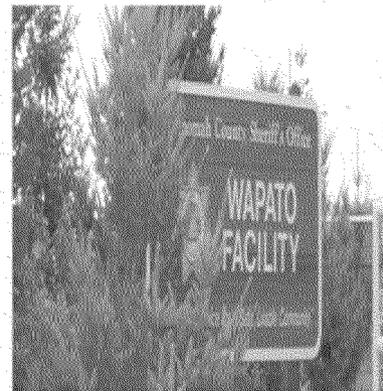

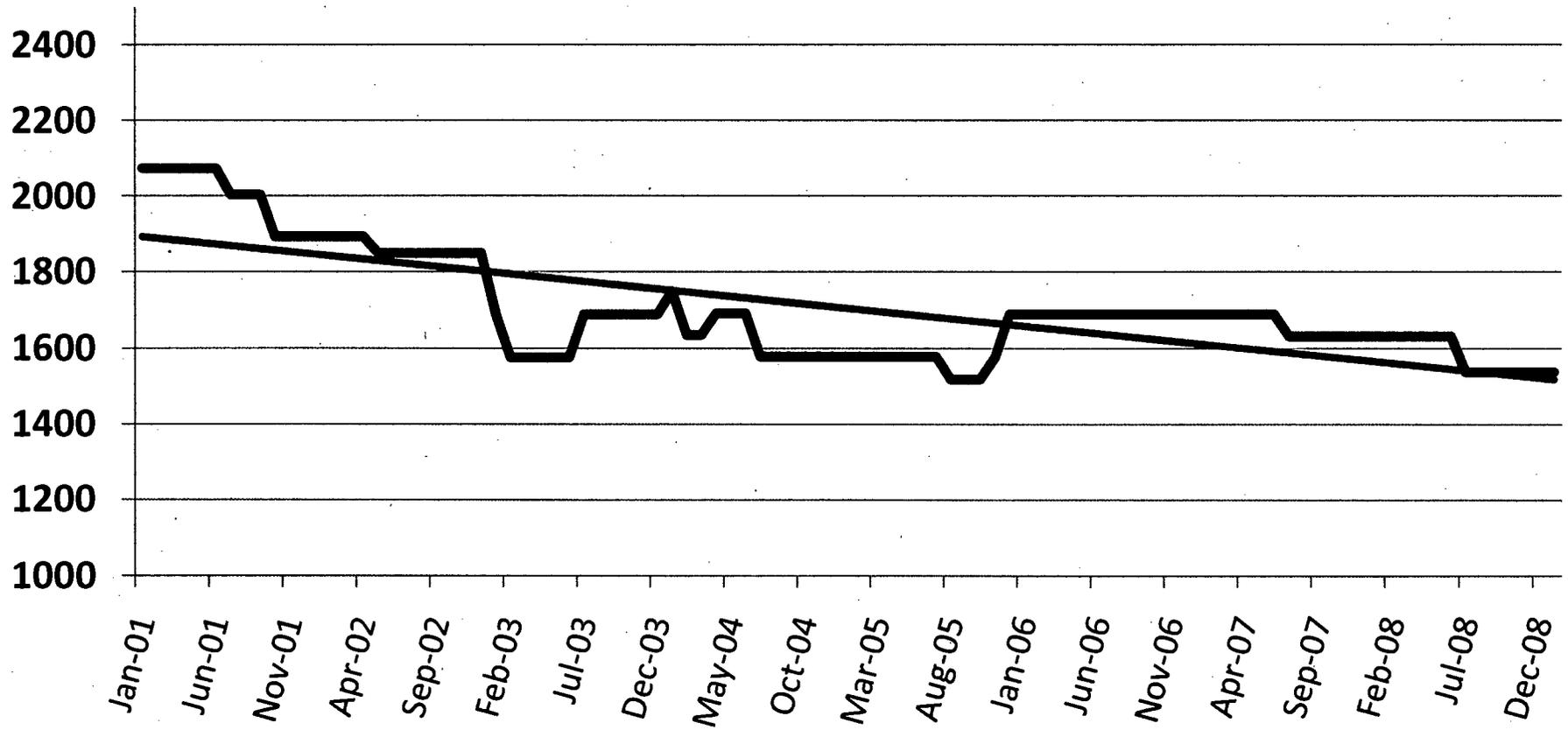

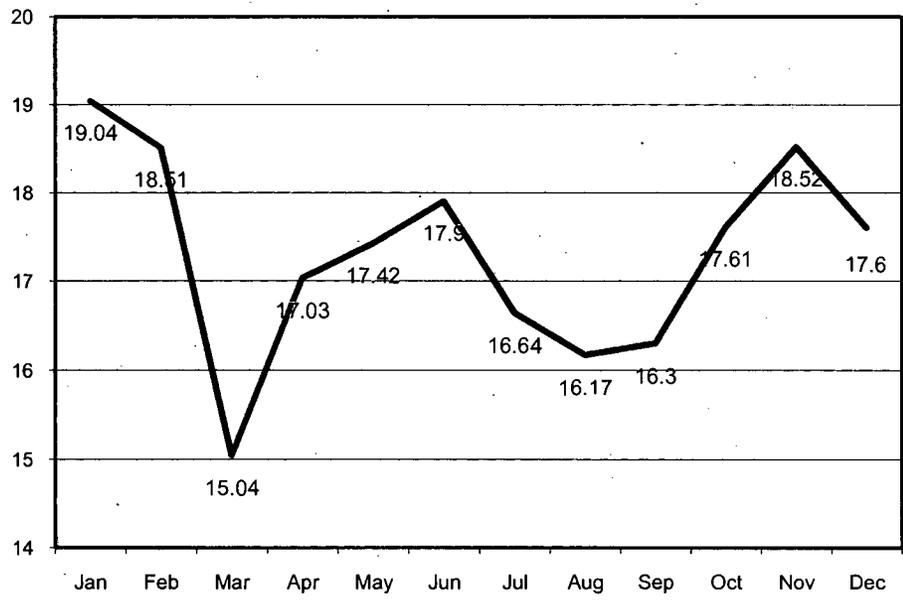
# Multnomah County Jail Bed Capacity History

Currently 1539

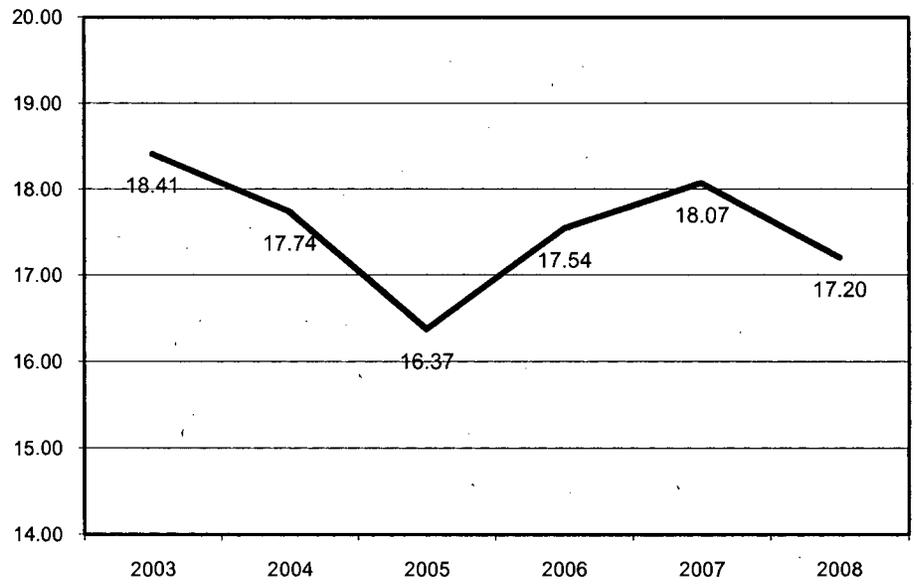


# Average Length of Stay (ALS) for 2008 is comparable to previous recent years

Monthly ALS (average length of stay) 2008

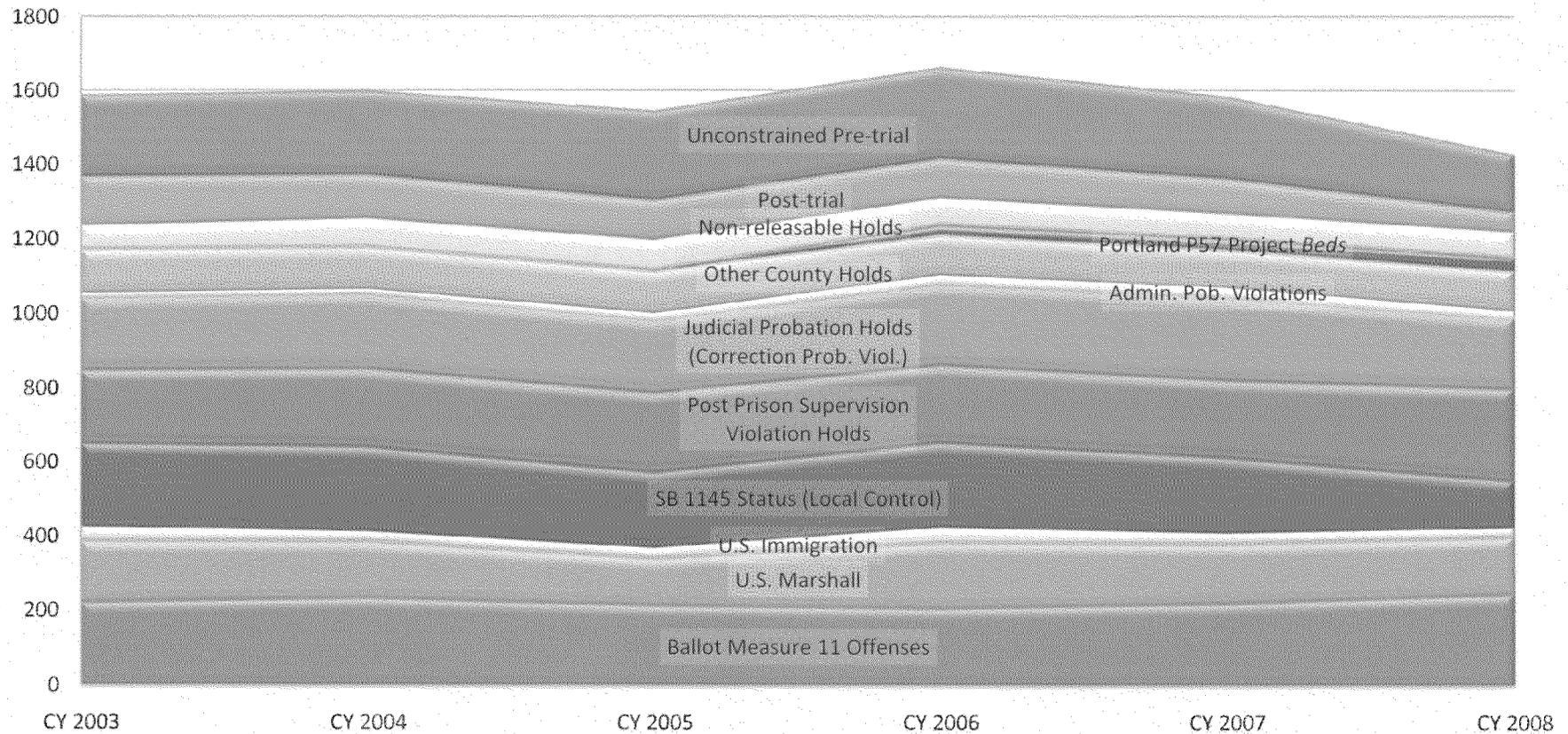


Yearly ALS (average length of stay) 2003-2008



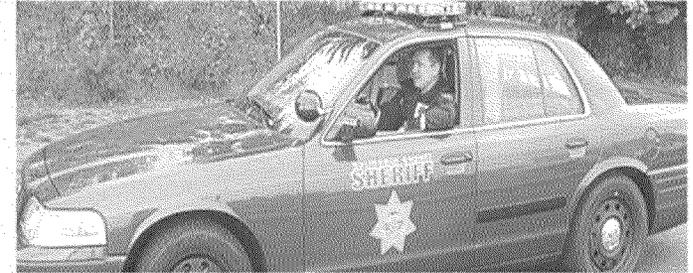
# Jail Bed Distribution by Type of Occupancy

Jail Bed Distribution by Type of Occupancy, ADP



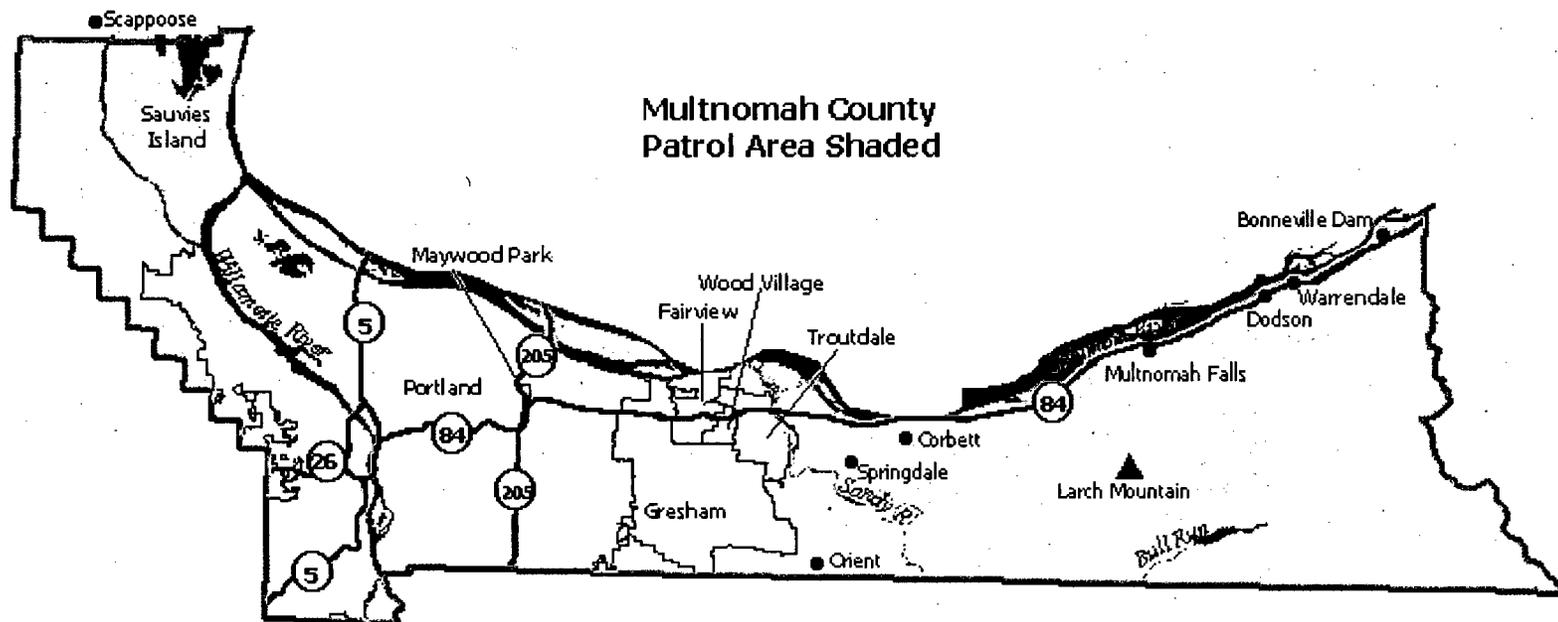

# MCSO patrols an area extremely large in geography.



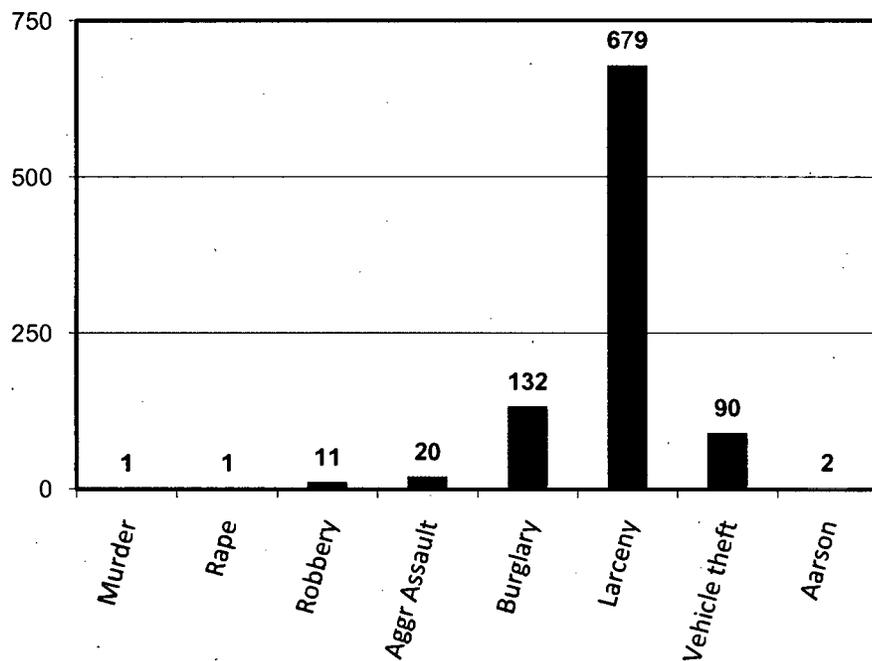

Sauvie Island, Dunthorpe, Wood Village, Maywood Park, Orient, and Columbia Gorge

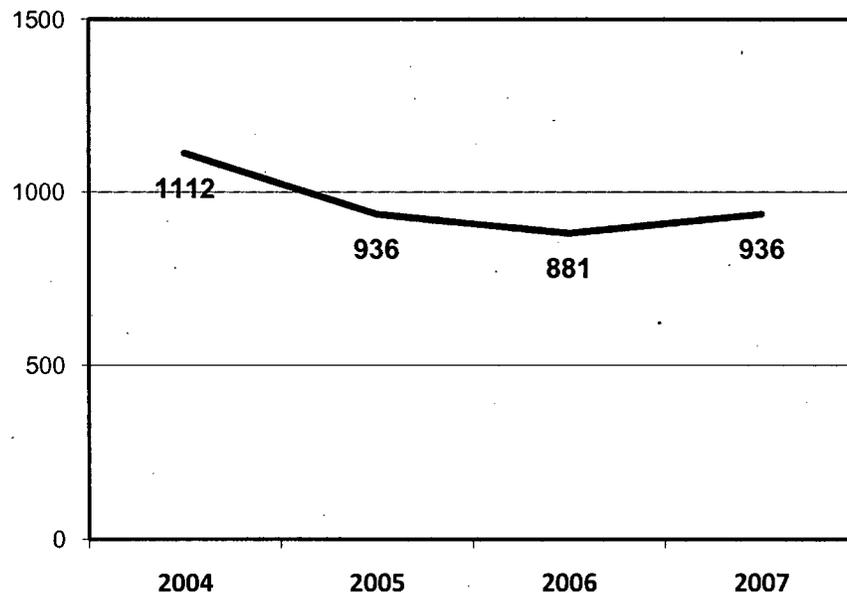


**Reported Part 1 (Serious Crimes) have held steady at approximately 1000 per year in MCSO patrol districts. Majority of these involve larceny.**

Part 1 Crimes MCSO Districts 2007

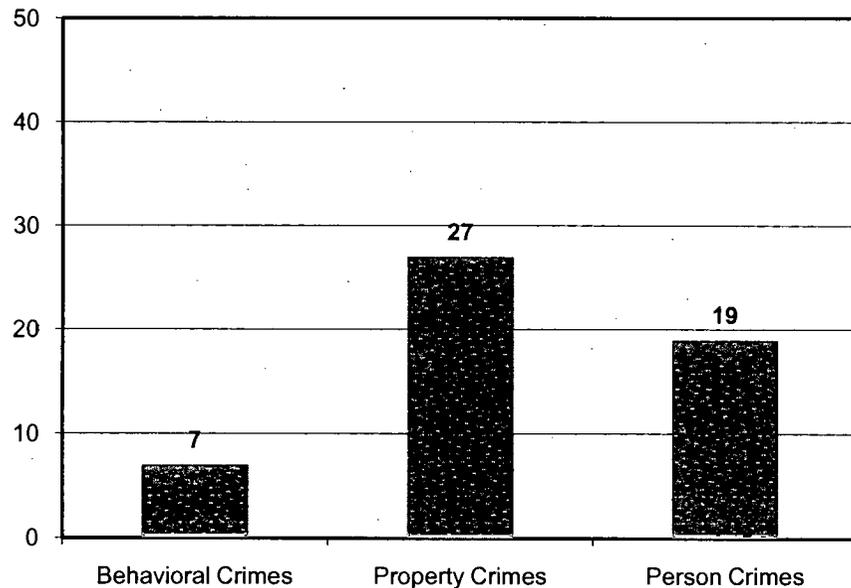


Total Yearly Part 1 Crimes 2004-2008

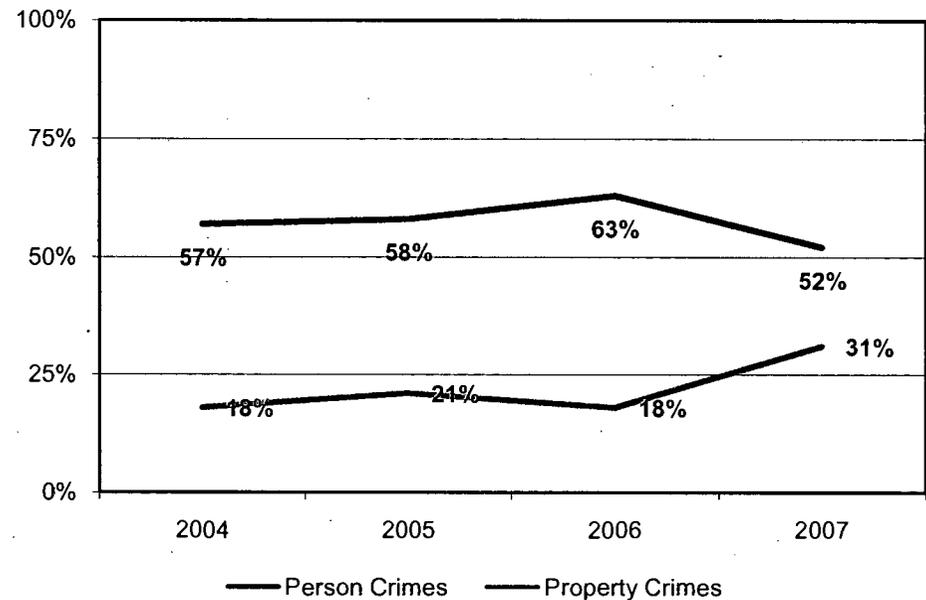


# MCSO detectives have cleared more than one-half of person crimes cases each year, with a large increase in the proportion of property crime cases cleared in 2007.

Active Investigations/Cases as of Dec 2008

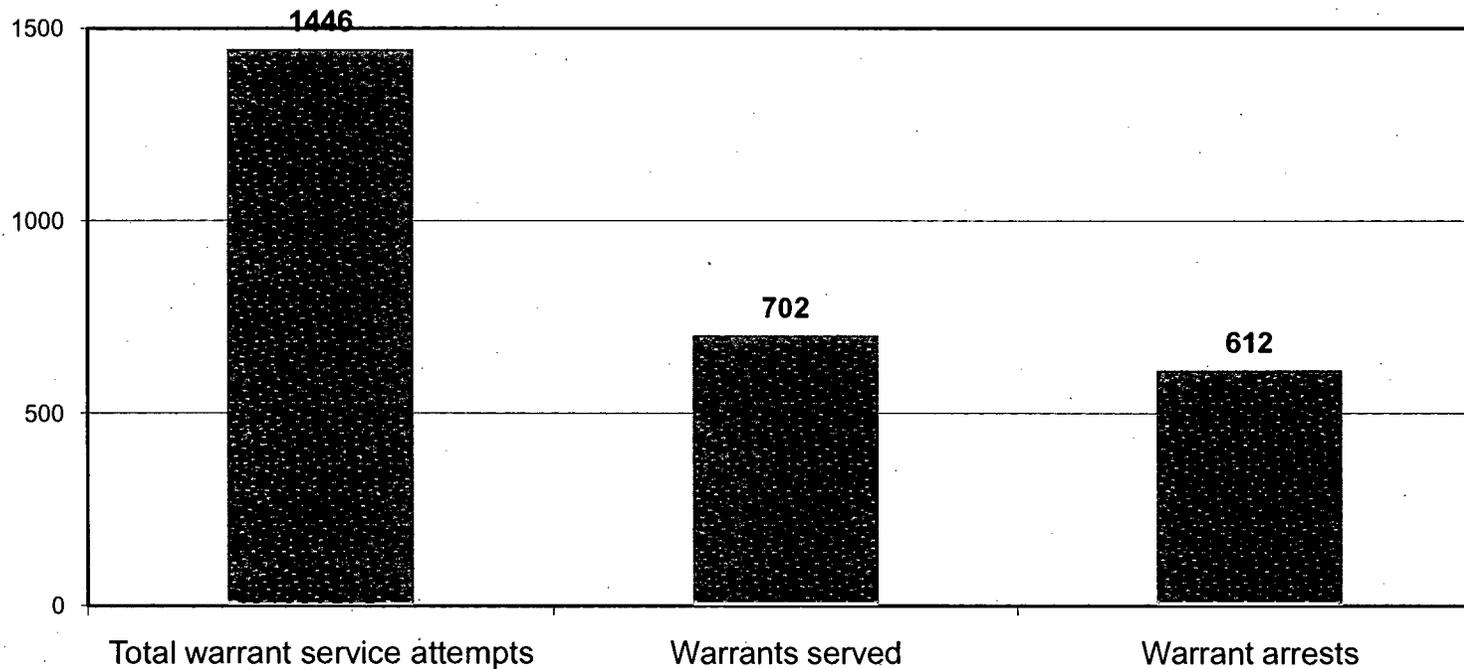


Part 1 Crimes Cleared 2004-2007



# Serving warrants removes unwanted persons from neighborhoods and help prevent crime.

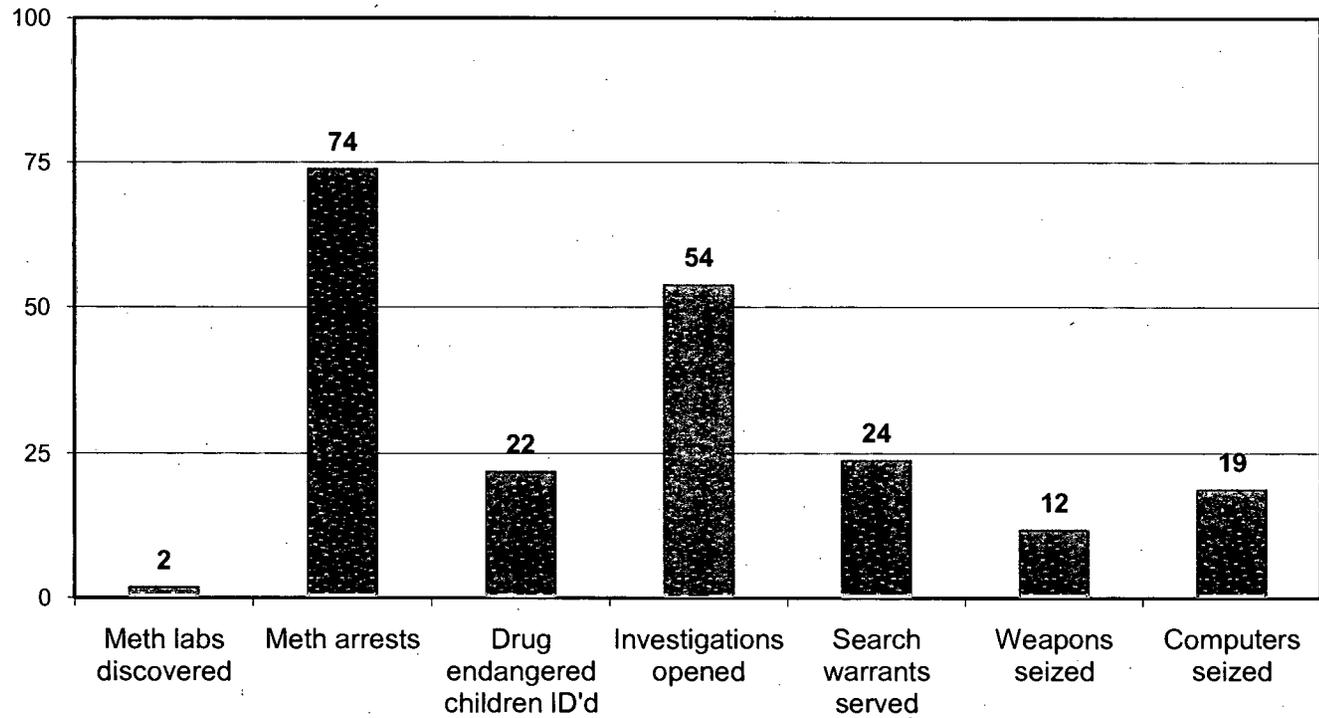
Estimated Warrant Activity FY 2008-2009

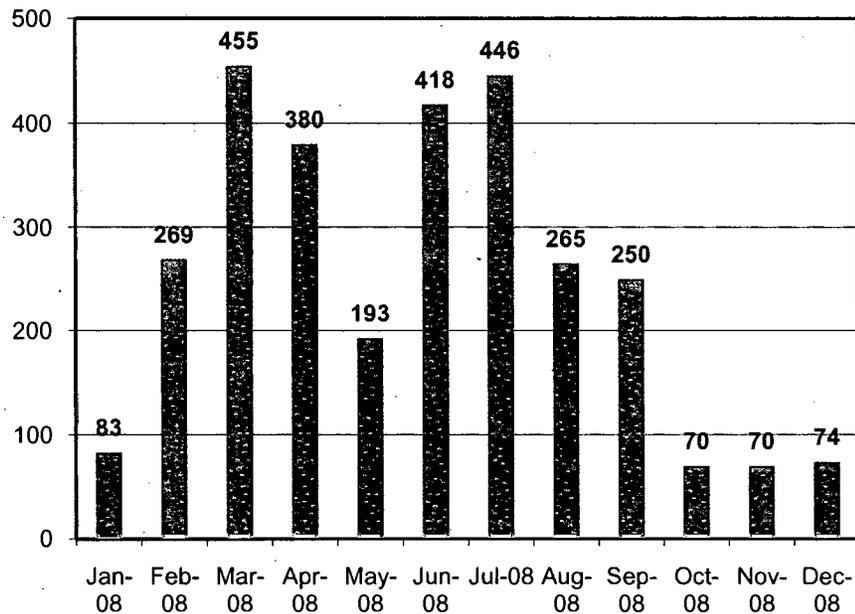
# Meth and meth traffickers continue to pose a threat to public safety.

Meth investigation outcomes FY 2007-2008

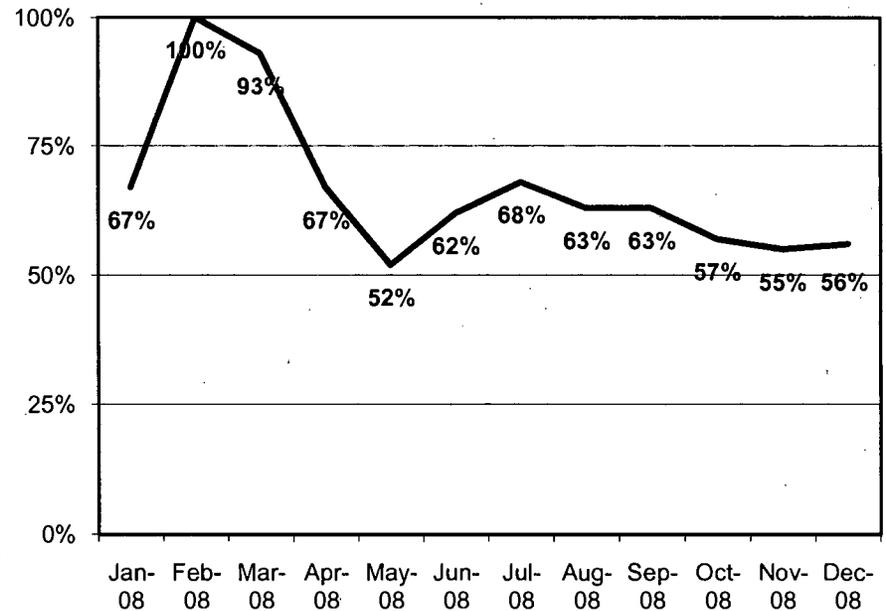


**MCSO River Patrol responds each month to more than half of all emergency calls for service on the waterways within Mult Co, while also conducting a large number of routine boater safety inspections.**

# MCSO Achievements and Successes in FY 2009:

## Corrections

- Renegotiated contract with US Marshal's Service.
- Enhanced *Parenting from the Inside Out* program to assist in re-integrating incarcerated parents with their children and families.
- Prevailed on binding arbitration proceeding that significantly improved sick leave accountability and put controls on use of comp time.
- Reduced the use of sick leave by 19% by carefully managing leave usage.

## Business Services

- Resource Analysis Unit produced original research reports on SB1145 offenders, Portland Project 57 inmates, DUII recidivism, women in county jail, drugs and prostitution, agency sick leave usage, and MCSO employee demographics.



# MCSO Achievements and Successes in FY 2009 (continued):

## Law Enforcement

- Warrant Strike Team composed of MCSO, the DA's Office and the Judiciary reduced the number of outstanding warrants from approx 30,000 to approx 25,000 between Oct '07 and Nov '08.
- Established the Corbett Resource Deputy, providing the community with a full time, single source contact.
- Conducted annual, 12-week Citizen Police Academy at Wood Village City Hall for residents of Wood Village and Maywood park to educate the community about the work of MCSO and build a closer relationship with residents.



# Issues & Challenges

## Policy Issues

- Balance the Sheriff's Office law enforcement and jail services with other public safety partners to ensure sufficient resources and services are available throughout the public safety continuum.
- Determine the appropriate role and use of Wapato.

## Short & Long Term Concerns

- Jail classification system is undergoing redesign based on suggestions from the National Institute of Justice.
- Need more housing choices for inmates, such as for medical, mental health, and work release, to ensure least restrictive and most cost-effective options are utilized.
- Double bunking in the MCDC restricts ability to provide direct supervision and accelerates depreciation of an aging facility.
- Decreasing jail beds makes it increasingly more difficult to group those needing mental health services into housing areas where such needs can be addressed, and reduces ability to house pre-trial offenders.



## Short & Long Term Concerns

- Decreasing jail beds pushes our inmate population closer to emergency population releases and reduces our ability to house pre-trial offenders.
- Uncertain impact of Ballot Measure 57, which increases sentences for drug and property offenses and crimes against the elderly.
