

BEFORE THE BOARD OF COMMISSIONERS  
FOR THE COUNTY OF MULTNOMAH  
ORDINANCE NO. 508

An Ordinance relating to County policy regarding the development of Blue Lake Park.

Multnomah County ordains as follows:

SECTION I. FINDINGS.

The Board of County Commissioners find that:

- A. On March 6, 1986, the Board adopted a resolution dedicating revenue for capital improvement needs of County parks. A copy of that resolution is attached hereto as Exhibit A and is incorporated herein by reference.
- B. As reflected by the public testimony on March 6, there is widespread public support for the County park system and for continued development of County parks.
- C. Adoption by ordinance of the policies contained in the March 6 resolution would be in the public interest, since incorporation of the policies in ordinance form will assure full opportunity for public notice and participation before the policies could be changed.

SECTION II. ADOPTION OF POLICIES.

The goals and procedures described in the attached Exhibit A are hereby adopted as County policy that shall not be altered without amendment or repeal of this ordinance.

SECTION III. EFFECTIVE DATE.

This Ordinance, being necessary for the health, safety, and general welfare of the people of Multnomah County, shall take effect on the thirtieth (30th) day after its authentication by

the County Executive, pursuant to Section 5.50 of the Charter of Multnomah County.

ADOPTED this 10th day of April, 1986, being the date of its second reading before the Board of County Commissioners of Multnomah County.

EXHIBIT A

RESOLUTION

WHEREAS, the Multnomah County Regional Park system is recognized as a valuable public asset providing opportunities for recreational, cultural, and environmental education opportunities and the preservation and protection of sensitive ecological areas; and

WHEREAS, the Blue Lake Task Force has recommended to the Board of County Commissioners that an interest-bearing capital account be established for the purpose of receiving public donations for planning, development, acquisition and marketing for the Parks System, beginning with the Blue Lake Park Master Plan;

NOW, THEREFORE, BE IT RESOLVED THAT:

1) The Multnomah County Board of Commissioners hereby adopts the goals as necessary by said TASK FORCE, as follows:

- \* To stabilize regional parks funding by ultimately reducing dependency on the General Fund.
- \* To provide capital required to fund Parks' planning, development, acquisition, and marketing, beginning with the Blue Lake Park Master Plan.
- \* To permit revenue generated by the Parks Division to directly benefit the Parks system and its patrons.
- \* To provide a vehicle to accept gifts and donations and to provide capital to leverage other monies.
- \* To provide an incentive to the public to support the Parks system, and to Parks staff to minimize costs and maximize revenues.

2) THEREFORE, in support of these goals, the Multnomah County Board of Commissioners hereby directs that the following revenues be dedicated to the Multnomah County parks program:

- a) Park Services Division revenues in excess of \$200,000, beginning in fiscal year 1986/87.
- b) Proceeds from all current, pending and future sales of County surplus right of way along Marine Drive.

- c) The Glendoveer receipts in an amount equal to the July 1, 1986 balance of the Recreational Facilities Fund plus the 1986/87 receipts from the management and lease agreements for the Glendoveer Golf Course, less normal annual expenses.
- d) Revenue generated by the County Parks Division in fiscal year 1985/86 over and above the revenue projected in the 1985/86 Adopted Budget.
- e) Unexpended parks appropriations from the prior fiscal year.

3) There is hereby established an interest bearing account in the County Treasurers Trust Fund, to receive and disburse donations from the public which are to be used exclusively for those purposes described in Section 1.

4) As part of the 1992/93 budget adoption process, the Board of County Commissioners shall:

- \* Evaluate the program and its accomplishments.
- \* Reassess the amount of revenue from the Parks Services Division to be dedicated for future capital development.
- \* Establish a new review date.
