General Information

1. What action are you requesting from the Board?

Authorize settlement of Multnomah County v. FMC Properties, LLC, et al, MCCC Case No. 15CV16237.

2. Please provide sufficient background information for the Board and the public to understand this issue. Please note which Program Offer this action affects and how it impacts the results.

This is a condemnation action to acquire property necessary for the construction of mitigation improvements required for the new Sellwood Bridge. The settlement will settle all issues in the case, including claims for just compensation, attorney and appraisal fees, and reconstruction of the entry driveway from SW Macadam Blvd. to the Freeman Motor Company customer parking lot, adjoining landscape buffer, sidewalk, curbs and gutters. This settlement does not affect any Program Offer. See #3 below.

3. Explain the fiscal impact (current year and ongoing).

The negotiated, recommended settlement is \$256,800.00. Sufficient funds have been budgeted to complete final design, right-of-way acquisitions, bridge project construction, and construction of required mitigation improvements.

4. Explain any legal and/or policy issues involved.

On December 18, 2003, the Board adopted Resolution 03-171 delegating authority to the County Attorney to settle claims and litigation against the County or its employees in

amounts up to \$25,000 per case. The County Attorney must obtain Board approval for all settlements of over \$25,000.
