# **LUSSA** **The League of Utilities and Social Service Agencies**

## **Chronic Arrearages Pilot Program**

### **Introductions:**

Households on limited incomes are often confronted with serious financial problems in meeting their utility bills. Many of these households live in housing stock with very poor energy characteristics, such as little insulation and old appliances. Consequently, a much greater proportion of their income goes towards energy bills than is typical of the rest of the population, sometimes in excess of 50%. Many of these households are the most vulnerable members of society - seniors, single parents with children under six or handicapped.

For many of these households, the problem isn't strictly an energy problem, it's also a money problem. When a household finds itself facing unexpected circumstances, it may be that high energy bills are the last straw. A senior citizen living alone in the family home on a pension barely adequate to meet expenses or a young mother with a preschool age child, who suddenly finds herself living in an old apartment and trying to juggle the expenses of day care with the income from a temporary job, are just two examples of the kinds of people who need energy assistance each year.

Over the years various programs have been developed by utilities, non-profit organizations and state and federal governments to provide cash assistance for these people in meeting these needs. The largest of these is the federally funded, state administered, Low Income Energy Assistance Program (LIEAP). In 1987, 82% of the households (averaged size 2.7 members) receiving LIEAP assistance had incomes below \$8,000 per year. Yet because of the specific nature of these programs, they are often unable to address the client's underlying cause of the utility bill arrearage, that of financial difficulties, and thus may provide little more than a "band aid" solution. This is evidenced by the repeat participation in LIEAP by almost two thirds of the households each year. Local agency workers do an admirable job of trying to coordinate a multitude of assistance programs for these households without having the luxury of time and funding for full case management.

Although payments averaged about \$190 per household, the total cost, including administrative expenses, was \$275 per household totaling over \$20 million in 1987. And the cost of these utility bill arrearages to the utility companies and indeed all ratepayers is even greater. Utility credit departments constantly dispatch servicemen to disconnect power to homes with overdue accounts. Even with energy assistance payments, Oregon utilities still had to write off over \$7.7 million in all types of uncollectible accounts in 1986.

## CHRONIC ARREARAGES PILOT PROGRAM

### The LUSSA Chronic Arrearages Pilot Program

The LUSSA Chronic Arrearages Pilot Program seeks to document strategies for assisting people to solve their household energy and financial problems by providing a comprehensive variety of structured services to LIEAP clients to include weatherization, utility bill payment scheduling, personal financial counseling, energy conservation education and cash assistance. The goal of the program is to enable clients to take control of their energy and finances to eliminate the client's need for LIEAP funds in subsequent years.

The LUSSA Pilot Program will be administered by the Community Action Agency of Portland (CAAP) with on-going project direction from the Research Committee of the League of Utilities and Social Services Agencies (LUSSA), a non-profit coordinating committee composed of representatives from Portland energy utilities and LIEAP agencies. Background information about the participants is included in the appendices to this proposal.

### Program Design

The Chronic Arrearages Pilot Program is designed to demonstrate a cost effective method to address client household's energy and financial problems by providing them with a variety of services as their individual situation requires. Not all homes will need to be weatherized and not all clients may need the same level of financial counseling. Development of a motivational framework for clients to succeed will be stress in all services.

Selection of participants in the program will attempt to reflect the demographics of the population in order to allow meaningful evaluation of the effectiveness of various strategies. Adjustment of energy consumption data allowing for weather variations will be included in the evaluations, as well as comparisons with control group performance that receives no assistance.

Program goals are:

1. Lower energy cost/percent of income;
2. Client meets financial obligations (money management);
3. Utility cost saving - internal (cost savings for utilities);
4. Client satisfaction, program participation and increased energy knowledge;
5. Continued participation with long term arrearage reduction;
6. Low drop off rate; and
7. Program replicability throughout the state.

It is anticipated that a follow up analysis be conducted on the participants after one year to determine long term effects of program participation.

The final report will include detailed statistical analysis and comparisons with present strategies of utilities and government programs in dealing with chronic arrearages, whenever possible. It is not expected that this pilot program will produce definitive answers as much as point the most promising direction for wider scale implementation. Indeed there are probably as many "answers" as there are households needing assistance.

The benefits derived from this pilot program will be shared by the utilities, clients and the state. Specifically, the utilities will enjoy reduced costs associated with disconnects. These savings should reflect a decline in time and resources associated with collecting unpaid bills. Further, the utilities will garner "community good will" by supporting and contributing to this type of endeavor. Then too, they can avoid additional regulatory costs (corporate attorney fees) by not having to appear before the Public Utility Commission to defend unpopular corporate actions. The client will enjoy lower energy costs as a result of the weatherization component of this project. At the same time the case management effort will ensure that the client becomes better informed concerning energy conservation and money management principles. If this program proves to be successful, the State of Oregon will be able to reproduce it in other localities throughout the state.

#### Program Description:

The Chronic Arrearages Pilot Program will involve 100 clients selected by the CAAP's six regional agencies. The agencies will screen sufficient applicants to ensure that each client's income is up to 150% of the federally defined poverty level. A letter will be sent to prospective applicants to schedule a face to face interview for final evaluation. LUSSA will be available to assist in reviewing client qualifications.

#### Other criteria include:

- A mix of participants of various demographic and age categories;
- Use of individually metered natural gas or electricity as sole heating;
- An accumulated utility bill arrearage (utilities to supply information);
- Previous LIEAP payment (state to supply information);
- Justification of client capability to improve status in meeting energy obligations; and
- Commitment to participate in the entire program.

In addition 100 other "control" households will be selected from other LIEAP participants. Efforts will be made to match the demographics of the participant households. These households will not be told about the LUSSA Pilot Program and their payment patterns and energy consumption will be monitored for comparison purposes.

## **B. Available Assistance:**

Local agency caseworkers will have the option to select from the following items as determined by the needs of the client:

1. Individualized payment plan developed by local agency and utility representative;
2. Energy education provided in conjunction with Community Energy Project by the City of Portland's Block by Block Weatherization Program. Participants are provided with basic caulk and weatherstrip materials and instructions on doing it themselves. Materials for low cost storm windows will be available.
3. Basic weatherization of dwelling provided by Block by Block Program. Energy conservation measures typically installed include attic insulation, broken glass replacement and basic air sealing measures.
4. Personal financial counseling provided by the non-profit Consumer Credit Counseling Services and OSU Extension Home Economics Program (these programs are included in the appendices). Programs have not been finalized with these groups at the present.
5. Cash payments to utilities, as determined by local agency. This is typically a monthly co-payment with client.

## **C. Case Management:**

Local agency staff are the key to program effectiveness. Because this is an innovative program, sufficient time must be allowed to familiarize the staff members with the options available under the program. Based on experience with LIEAP two hours will be allocated for initial intake of clients with monthly followups of approximately 45 minutes each with the client during the program. This amounts to about 12 hours of contact per client during the pilot program. Steps in the process include:

1. Selection of household for the program	- .5 hour
2. Training of caseworker in pilot program	- .25 (per client)
3. Intake and initial development of program	- 1.75
4. Monthly followup with client household	- 8.5
5. Final summary of client household participation	- .5

#### **D. Data Collection:**

Local agency staff will collect the following information on each participant. All information will be confidential.

LIEAP intake data - including demographics of household and changes in household during the program.  
Explanation and justification for all services received under pilot program.  
Monthly budget and expenses at intake and throughout program.  
Description by local agency of client's progress throughout program.  
Monthly utility consumption and utility payment history for year prior to program and throughout program.  
Energy characteristics of home before and after weatherization.  
Energy consumption of control household will be monitored for comparison with participants.

#### **E. Evaluation:**

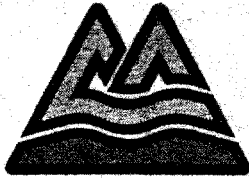
Analysis of the data collected during the LUSCA Chronic Arrearages Pilot Program will seek to provide answers to the following questions:

1. How did household energy use change?
2. How did household financial situation change?
3. What program elements and other factors influenced that change?
4. What are the demographic characteristics of the participants that succeeded in changing their situation?
5. What areas can the program be simplified to be more cost effective?
6. How can this program be made more self sufficient?

## **MULTNOMAH COUNTY RESTITUTION CENTER**

August, 1988

The Multnomah County Restitution Center began operation on February 23, 1987. Located within the community, it gives carefully screened sentenced persons a chance to make compensation for their actions and to re-enter the community as responsible citizens. Residents have paid \$20,819.87 in court ordered restitution and fines and \$108,984.83 to the County for room and board. In addition, 6,917 hours of community service hours have been contributed by residents to non-profit public and private agencies and churches in the community. They have provided approximately 17,570 hours of in-house work to maintain the Center (this does not include the cleaning of their own rooms).

### **ACCEPTANCE/SCREENING CRITERIA**

Residency at the Center is a privilege granted only after careful consideration of the candidate's behavior, attitude and past record. A primary concern in screening is to safeguard the community, the staff and other residents. Citizen volunteers, together with Corrections Officers and Counselors, meet weekly to consider potential residents. During the first sixteen (16) months, 939 candidates have been screened with 750 residents accepted and 189 rejected.

### **PREPARING PRODUCTIVE CITIZENS**

Treatment and counseling is central to the concept of the Restitution Center. This program helps prepare residents for their return to the community.

Programs offered include:

### **PROPOSED EXPANSION**

The current City license limits the Center's program to eighty (80) residents. We desire to expand the resident limit to 160. Expansion is expected in incremental phases and staffing will be increased to ensure continued safe and successful management of the program in the community.

The screening criteria and process will remain the same.

Direct citizen involvement of both the Citizen Advisory Board and the Resident Screening Committee will continue.

# Restitution center success story

## wins over foes

□ The sheriff wants to expand the downtown center which neighbors say brings a sense of security

While state and county officials grapple with inadequate and crowded prison and jail systems, a new jail in downtown Portland is meeting with success.

The 18-month-old Multnomah County Restitution Center, housed in the former Rajneesh Hotel at 1115 S.W. 11th Ave., is working so well that it may be expanded in the next six months.

When it first was proposed in 1986 by Multnomah County Sheriff Fred Pearce, opponents, fearing increased crime in a mostly residential area of downtown Portland, tried to squelch the idea during several city and county hearings.

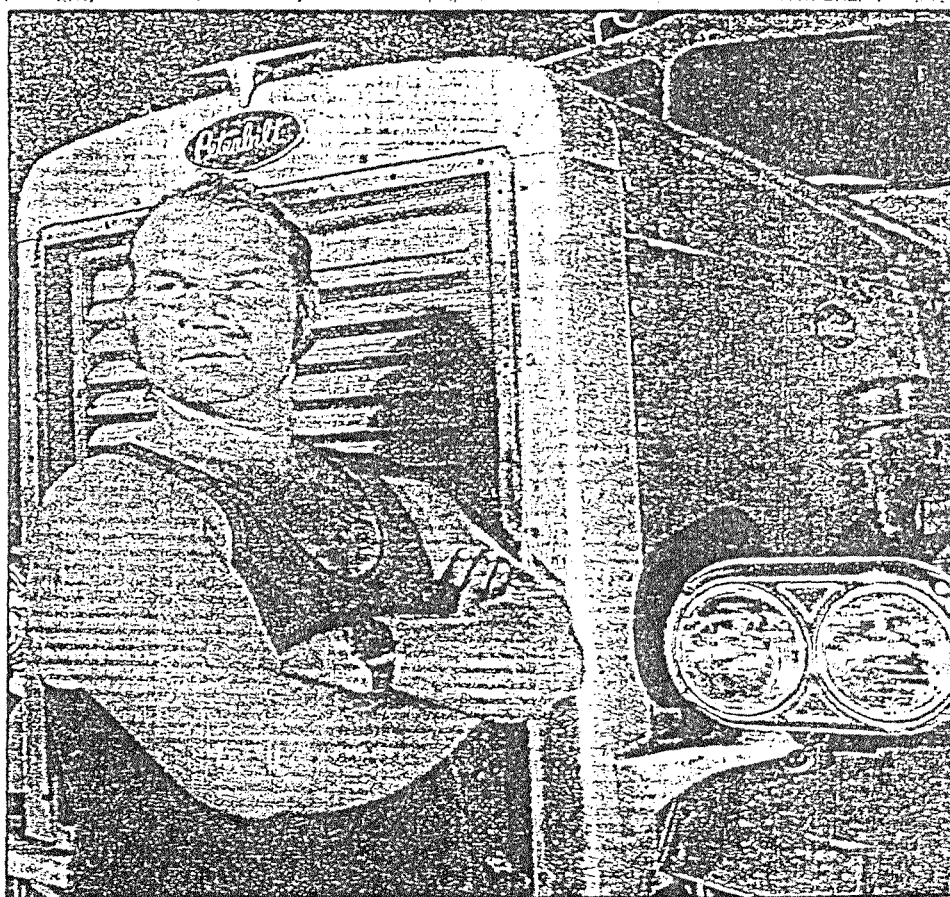
But their original fears have gone unfounded: Only one of the center's residents has been convicted of a crime while living there and that was in his workplace outside the downtown area. Overall crime in the immediate area has dipped slightly since the center opened, according to Portland police statistics.

Nearly 18 months after the center opened, many of the original opponents now support the center. Residents and local property owners say it is a "good neighbor" that brings a sense of security to the area.

"As a place where children of all ages come, there was concern by the volunteers about safety issues, but safety and crime issues have not increased," said Ann Kohler, assistant executive director with the YWCA, a block away.

The center has been so successful, in fact, that Pearce wants to expand it from 80 to 160 beds; the expansion, if county funds are available, would begin in January.

Most of those who are allowed to serve time in the center instead of in the county Justice Center or the Multnomah County Correctional Facility are there for driving offenses, usually associated with alcohol or drug abuse. But residents are being admitted for increasingly more serious crimes, including attempted rape, assault and incest.

The few critics the center does have say more prisoners should be required by judges to pay restitution. And they question why, at a time when other Multnomah County jails are overcrowded, the restitution center is not usually at its full capacity of 80 residents.

Those who praise the center point to the two screening committees that review each inmate before he is allowed

to serve his time. Composed of four county corrections counselors and two downtown residents, the committees are the result of negotiations between Pearce and city and county officials who approved the center. If either of the community residents on the committee opposes a prisoner, he is rejected.

In the first 16 months, according to the most recent statistics available, 750 inmates have been accepted; the committees screened 939 candidates and rejected 189, based on scores reflecting their past records.

The first inmate considered during a recent committee hearing was a mechanic sentenced to 30 days for drunken driving. Despite two previous sentences, he has had no arrests for several years. With two years of college, he was considered educated enough to be motivated to change his behavior. He easily was given the OK.

But another inmate was not so deserving. With two counts of escape on his record, one in which he left Rocky Butte in a laundry cart, the inmate, now sentenced to a year for driving with a suspended license, was considered too great an escape risk.

## A stopgap

Meant as a replacement for the work release center in Troutdale, the restitution center opened Feb. 23, 1987. The center's philosophy is to put people back into the community better than when they came in, with improved skills and self-worth, said Capt. Thomas Slyter, the center's original commander who was promoted to captain in June and reassigned to command the Justice Center and courthouse jails.

The men who enter the center must be employed or seeking a job. They must do maintenance around the building, perform community service work and attend self-improvement courses. They cannot work, shop or loiter in the downtown area while serving their sentences. Their average stay is 50 days — longer, in some cases, than the sentences served at other, overcrowded Multnomah County jails.

"It's a stopgap between hard lock-up and the street. In a jail, there is nothing to change their feelings and behavior. They are put back in the same environment that put them there in the first place," Slyter said.

The average resident is between 18 and 47 years old, has not completed high school and has few job skills. Only men are allowed to serve time at the center; the county operates women's programs through contracts with the YWCA, Volunteers of America and Our New Beginnings.

Their crimes could involve anything, Slyter said. "As long as they're sentenced, we look at them all. The only ones we reject are those who are a threat or a danger to the community."

"Part of the perception the community has is that these people are different than you or I," he added. "They're really not. They have the same attitudes, the same perceptions. Some have the same values; some are in here because they made one big mistake."

Kurt Anderson, 33, considered a success story by the center's operators spent a month at the Multnomah County Correctional Facility in Troutdale on a year's sentence for a probation violation before entering the restitution center in February. He was released in April and is now on the county's Intensive Street Program, which allows the prisoner to stay at home but requires him to wear an electronic bracelet to enable his whereabouts to be monitored.

Anderson's original crime was an assault, which he said was the result of his alcoholism.

He credits his turnaround to the restitution center.

"It teaches you to deal with responsibility and teaches you how to play by the rules. They don't let you stretch them very far. It's a learning experience, if you go about it the right way."

Anderson was released in April after serving three months there for a parole violation. He said he appreciated the relaxed atmosphere that enabled him to begin recovering from his alcohol addiction. Anderson, who continues to remain sober, is out of trouble now and back with his wife and three children.

"I kind of enjoyed it," he said. "If I wanted to be away from people I could go to my room and think about what was going on with my life. It was a lot healthier environment; I would have been liable to go out and commit a crime if I had been dumped out on the street."

## 22 escapees

In the past 16 months, 22 have escaped, which was about normal during an average two-month period for the Troutdale facility when it was the work-release center, Slyter said.

Of those who served time at the center, 25 percent were returned to the Justice Center because of disciplinary problems. Although a recidivism study recently began, the center still is too new to determine how successful it has been in keeping people out of the system for several years, said Larry Reilly, the center's counseling supervisor.

The county bought the four-story building in 1986 for \$1.6 million and spent \$265,000 to refurbish it to meet fire codes and security requirements.

It is operated with a \$1.5 million annual budget; daily costs average \$53.43 per man per day, but these are offset partly by room and board — a minimum of \$5 per day — paid by those who are employed. Since the center first opened, the residents have paid more than \$108,984 in room and board.

The restitution center's lobby looks much the way it did when the Rajneeshes were there: The overstuffed couches and royal blue carpet remain, although the pictures of the Bhagwan Shree Rajneesh, the cult's leader, have been removed.

No bars cover the windows; the front door remains unlocked during the day and the fire escape doors are unlocked from the inside. The residents wear their own clothes instead of prison uniforms. They joke with the officers; the atmosphere is calm. In the past 17 months the resi-

dents have done more than 6,917 hours of volunteer work for non-profit organizations and public agencies and churches. Jobs included sorting food for Project Second Wind, painting the East Orient School in Gresham, sending out mailers for non-profit agencies and refurbishing the downtown YWCA.

The employed residents turn over their paychecks to the center's officials. From those checks come payments for room and board, money for family expenses, reimbursement for court costs and, if the judge has ordered it, restitution to crime victims.

Restitution payments and fines have totaled more than \$20,819. This "blood, sweat and tears" restitution is another reason the center is successful, said Carol Edmo, a member of the citizens advisory committee. Unlike the screening committee, which determines who will enter the center, the 13-member citizen advisory committee, composed of downtown residents, property owners and business operators, makes recommendations on the center's policies and volunteer work.

Edmo, who works in the Multnomah County public defender's office, says the restitution center is unlike any other corrections institution she has seen. Residents display a "courtesy and a pride of a different kind. You clearly get a feeling of self-esteem."

The elements of success include maintaining a ratio of one counselor to 20 residents, considered low by most corrections standards; the non-prison atmosphere of the building; and classes offered to residents about substance abuse, being a parent and goal-setting.

"I think it's a good model nationally and internationally," Edmo said. "I feel it's a real success story."

But, said Jim Horne, a citizen member of the screening committee, more residents should be required to pay restitution.

"I have a record of every person ever processed through here. Of the over 400 I've screened, less than one of 13 is ordered to pay restitution," he said. "That figure could be four times as large. That is the only weakness of the restitution center."

## Expansion debate

While Multnomah County Circuit Judge James Ellis agrees the program is successful, and he would like to see it expanded. The center, he said, provides more protection for the community because prisoners there serve some time, unlike those who may be released from the Justice Center or the Multnomah County Correctional Facility because of overcrowding.

"Two convicted child molesters were turned loose," he said. "One lives in a downtown hotel. The only difference between that and the restitution center is that he is not monitored."

At the heartbeat of the center, corrections officer Dan Carriethers mans the security station.

Because screening committee members at first were particularly careful about whom they allowed into the center, the population remained small for the first year. But as more men complete their sentences without incident and those with higher risk scores are accepted, the center has begun to reach capacity, Reilly said. In the past six months, there have been waiting lists of six to 12 prisoners, he noted.

Despite positive responses from several residents and property owners surrounding the center, Doug Goodman, president of City Center Parking, continues to oppose the center.

"I have not changed my feelings whatsoever," and Pearce's proposal to double the occupancy is no surprise," Goodman said. "I did not feel it was proper in the downtown area. It is not conducive for people to shop where a rehabilitation center is."

Businesses might be reluctant to move into the area, Goodman added. "I don't know who would want to put an office building across the street."

But the elderly residents of the St. Francis Hotel across the street feel the restitution center provides more security because of the appearance of uniformed sheriff's deputies and county cars, said Dennis Rose, a desk clerk at the St. Francis Hotel.

The president of the Downtown Community Association, Leo Cross, said the group, which originally was against placing the center downtown, now calls it "great."

"We were concerned because of the criminal element that was going to be housed there," Cross said. However, he said, the center has kept a "very low profile; you really don't know the place exists. It has not affected property values detrimentally."

Although property values generally are depressed in the area, that cannot be blamed on the center, said Dan MacNaughton, broker-owner of the Real Estate Investment Group.

MacNaughton, whose firm owns a 34-unit apartment complex south of the center, also opposed it originally, but believes now that it has been run well.

He is concerned, however, with Pearce's plans to expand.

"What's going to happen next? The system is just bloated. The restitu-

tion center is in an area where there are more temptations, with prostitutes and drugs.

## Residents see benefits

The center's residents generally express satisfaction with it and often say they are learning how to take responsibility for their actions. But those who are not working during the day complain of boredom and express concern about going back onto the street before they're ready.

Clarence Jackson, 45, spent 50 days at the center for possession of marijuana and was released in July.

"It's a ludicrous situation to put anyone in," Jackson said while at the center. "I just sit around reading, twiddling my thumbs. There's nothing else to do, nothing else for anyone to do. Stuffing envelopes—that's not reformation and rehabilitation."

Michael Fultz, 29, served time for driving with a suspended license and attended an alcohol treatment program while at the center. He was released in June.

Fultz, who was injured on a construction job and was unable to work toward the end of his stay, also complained about the lack of activities at the center. "If it had a gym in here, it would be perfect," he said. But, he said, "I've had a lot of time to do a lot of thinking. It didn't only affect me, it affected my whole family. I don't want to put them in that position again."

Reilly agreed that the center could do nothing more than provide an opportunity for residents to learn how to be responsible for their actions.

"We can set up a milepost in a person's life where they can look back and make a real change," Reilly said.

"They're going to definitely have a real hard time of it" on the street, he added. "This is only temporary—out there is the rest of life."

The residents of the Restitution Center have become some of the best neighbors any community could have. Many non-profit organizations have benefited from your help.

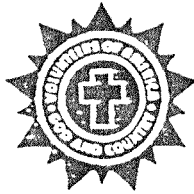


Dear Sheriff Pearce:

## County provides labor for school's new coat of paint

East Orient School isn't bright blue anymore.

The school at 7431 S.E. 302nd Ave. is wearing a new coat of pearl gray paint, applied this summer by some special volunteer workers.

And the improvement project is being completed at "a significant saving" to local taxpayers, Superintendent Jim Buck said.

"I'm hopeful that it will give a fresh look to the building — one the patrons can appreciate, especially at the cost at which it was done," Buck said.

Multnomah County Restitution Center residents performed the work at no cost to the district. From July 27 through Aug. 6, from three to six men from the center worked on the school building approximately seven hours daily Monday through Thursday, Buck said.

"The workers have certainly surpassed my expectations both in terms of the quality as well as the quantity of work," he said.

The workers have contributed 225 hours of work to the project, Buck said. If the district had had to pay for the labor, it probably would have cost "in the neighborhood of \$5,000 to \$8,000, maybe as high as \$10,000," he said.

Instead, the project will cost the district approximately \$2,000 for the paint and some change for soda pop furnished to the workers, Buck said. Buck and the district's maintenance supervisor, Bob Bourgo, also have transported the workers to and from the site a number of times.

The building had been scheduled for painting by volunteer patrons earlier this year but both dates for the district paint party were rained out. Buck, who said rounding up volunteers to paint the building is difficult during the summer, said he was anxious to have the project completed before students returned for the school year and before the weather changed.

Buck learned about the community service work program at the restitution center while he was searching for an alternative to a volunteer patron work party. Buck wrote to restitution center officials and his request won the favor of a community advisory committee.

"We certainly have had a good experience in having them out here," he said. "I have been very pleased with the workmanship and the care they have been taking on the project."

School officials originally proposed for residents from the center to work at the school site for a week, doing preparation work such as taping and sanding, Buck said.

"But this crew worked so diligently . . . and so we've just

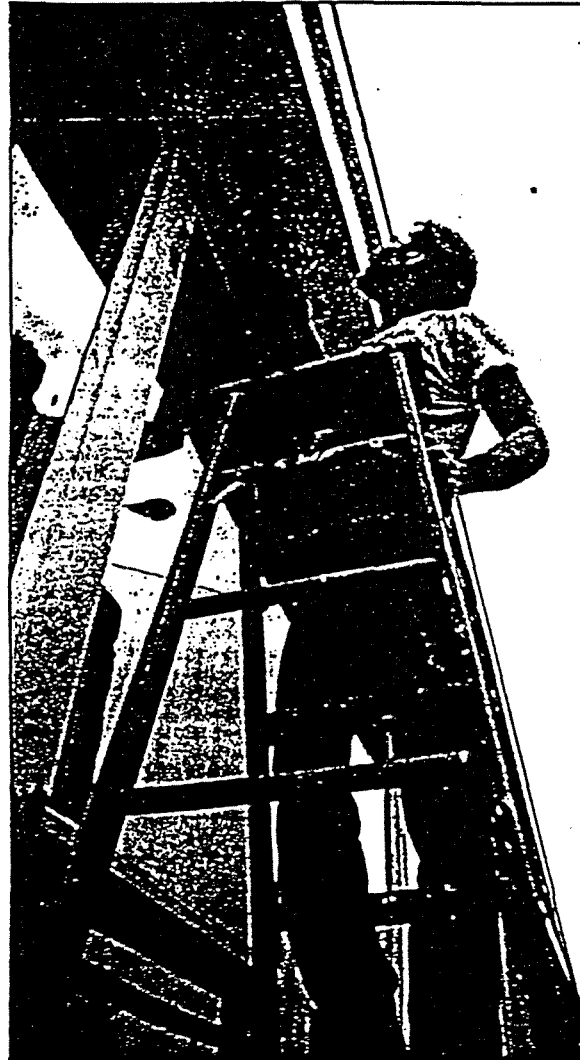

continued," he said.

In a letter to Lt. Thomas B. Syster Jr., commander at the restitution center, Buck said he would be happy to serve as a reference for other groups considering community service projects.

Andres J.R. Rocha, 26, said he was scheduled to be released from the restitution center this week after spending nearly two months there for probation violation. He said the school project provided him with "a good opportunity" to gain experience as a painter. Rocha said he hoped to return to the school to help paint the exterior trim on the building.

Richard Smith, 22, who has been at the center for about a month for probation violation, said he expected to be released Sept. 24. He

said community service work provided people with "something constructive to do" and a chance to build character.

"I feel a lot better about myself for doing something productive," Smith said.

Tom Lochamy, 26, who has been living at the center for about seven weeks for probation violation, said he is scheduled to be released Sept. 4. Lochamy, who said he had worked as a professional painter, said the project offered him an opportunity to "get out in the fresh air and get some exercise," and break the "monotony" at the center.

"The finished product is super," Lochamy said, admiring the work performed by the volunteers. "I don't think you could ask for any better results even if a contractor came in."

## PROJECT SECOND WIND UPDATE:

### Interagency Pantries Replenished for Spring

PROJECT SECOND WIND blew out of town leaving an incredible amount of canned food for hungry Portland area residents. The final totals revealed that 155,000 pounds of food were collected and \$16,000 was raised from concerned students and citizens.

Highlights from PROJECT SECOND WIND include:

- ★ A rainy, but enjoyable Mountain of Food Rally on March 4.
- ★ Improved participation in Clackamas County (three schools participated in 1987, 13 schools participated in 1988).
- ★ Continued record food collections from: Markham Middle School - 15,175.5 lbs. Three Lynx Elementary School - 17.25 lbs. per student Charlotte Stelzer from Gregory Hts. - 685 lbs.!

The PROJECT SECOND WIND committee also noted marked improvement in other areas of the drive as well. Better organization of the pick up and delivery of the food from the schools resulted in early completion of pick-ups and efficient re-boxing of food. Interagency Food Bank agencies were treated to earlier food distributions. The Awards Ceremony also ran so smoothly that students and business participants were honored and recognized in record time.



## "If Nobody Did It, Then Nobody Would Get It"

### Multnomah County Restitution Center Lends A Hand for Project Second Wind

Everyone knows PROJECT SECOND WIND (PSW) helps many hungry people. Not only do the shelves and cupboards of Interagency Food Bank's 160 member agencies receive valuable supplies of food, but Portland area students learn an important lesson about hunger in their community. Local businesses join the project to help feed the hungry.

Another group of people benefited from the PROJECT SECOND WIND effort. A group that most people don't think about. Residents from the Multnomah County Restitution Center were called upon to help out at the warehouse with sorting the food that came in from PROJECT SECOND WIND.

The warehouse (donated to the Interagency Food Bank by the Port of Portland) is a busy, hectic place during the canned food drive. Literally tons of food are brought to the port warehouse as the schools and businesses complete their drives. At least ten volunteers are needed everyday to help unload, weigh, sort and repack food into boxes for the Food Bank's agencies.

At first, some of the men were disgruntled about the task assigned to them. By the end of the week, many residents felt good about what they were doing. This is the second year the Interagency Food Bank has asked the Restitution Center to help supply volunteers to sort the thousands of pounds of food that comes in from the city-wide food drive.

Most of the men are repeat offenders. The crimes they have committed are not violent ones. Property offenses and moving violations are among the offenses committed by the residents. Their stay at the restitution center can be anywhere from ten days to one year.

Although many of the residents did not voluntarily go to work at the PROJECT SECOND WIND warehouse, Michael Siegelbaum did. Michael was convicted of driving while suspended and has been at the Restitution Center since January. He was scheduled to be released in April. He enjoys working with his hands, and looks like the kind of guy who would be very much at home under the hood of a car.

"Working here this week makes me feel like I'm doing something for someone else for once," said Michael. "There's a lot of people out there that need help. This is the third day I've come down to volunteer."

David Morris will be getting out of the Restitution Center in June. He's a tough looking guy, with a muscular build and a face that looks like it doesn't smile much.

He's been in the center for only a few weeks. He was convicted of driving while suspended and possessing and distributing controlled substances. When asked why he volunteered to work at the PROJECT SECOND WIND warehouse, he said, "It gets me out of doing nothing all day."

For a moment, it seemed that that was all he was going to say. But then he added, "I have a family. They're without me now. They might be needing some of this food right here. The work is not hard, and by working here, I might even be helping my own family."

David Morris didn't look so tough anymore. "Even when I get out, as long as I'm not working, I'll help out wherever I'm needed." He paused a moment before he said, "Besides, if nobody did it, then nobody would get it." The face that looked like it never smiled broke into a broad, toothy grin.

### SEXUAL ASSAULT FORUM SET FOR N.W. PORTLAND

Citizens in northwest Portland and other areas are invited to attend a public forum sponsored by West/Northwest Neighborhoods Against Crime concerning sexual assault. Some recent incidents in the N.W.D.A. neighborhood have raised concern about the safety of women in the neighborhood. The forum will include a speaker from the Portland Police Sexual Assault Prevention Program. Some issues that will be discussed at the forum include: a) What is the extent and nature of sexual assault offenses in N.W. Portland?, b) What are the myths and facts about rapists and rape victims?, c) What can you do to prevent sexual assault?, and d) What can you do if threatened with sexual assault?

The forum will be held Monday, November 16, from 7-9 pm in the Friendly House gymnasium at 2617 N.W. Savier. If you have questions, call Jeanna Cernazanu at 223-3356.

### DOWNTOWN RESTITUTION CENTER WORKING

"In the community, for the community" were the words often heard during the permit seeking process for the Multnomah County Restitution Center located at 1115 S.W. 11th. The Restitution Center has now been in operation for six months and the promise of residents who will "compensate the community for their actions" is being kept.

During the first six months of operation, over \$20,000 has been collected from residents in daily room and board. In addition, over \$30,000 has been collected for court costs, restitution to victims, court ordered child support, and probation. All this in addition to paying taxes!

Another form of compensation has been accumulated in over 1,800 hours of Community Work Projects for non-profit social service agencies in the community. Residents have painted child care centers, unloaded food supplies, prepared bulk mailings, assisted with downtown preparation and dismantling of Artquake, worked on downtown litter and trash patrols, and completed numerous other community projects.

The Center is indeed proving to be a good neighbor and the residents are re-entering the community with jobs, a sense of responsibility, and a commitment to be productive members of our city.

# Volunteers help Sheriff's Office

Crime is a popular topic of the 1988 election year campaigns. Neighborhood Associations are gathering citizen involvement committees in effort to insure public safety for residences and businesses. But a positive approach to crime has been in place in the Multnomah County Sheriff's Office for many years. That approach was achieved through the long hours of volunteerism in the Sheriff's Office Corrections Division. The sheriff's office has over 100 volunteers working within its recreational facilities. These volunteers perform a wide variety of tasks from answering telephones, tutoring and conducting educational classes, serving on committees and performing volunteer ministry. Over 5,000 hours of service were distributed during 1987. These volunteers are fighting crime on a personal, individual level. They realize change and personal growth only come in small steps. Their desire is to assist the county's inmates in taking the small steps toward leading productive lives in our community. An example of such a voluntary effort is Karen Haney. Haney came to

the Corrections Division in February 1986, hoping to give of her time to the counseling staff at the Multnomah County Detention Center. She is the single mother of three children and is a woman of boundless energy. She quickly assessed the need for a "self-esteem program" for inmates, researched the community for such a program and convinced the administration to allow her to begin structured classes with maximum-security prisoners.

Haney says she believes in helping people. She has completed her degree in psychology at Portland State University and is currently employed at Mental Health Services West, Inc. Haney has contributed between 400 and 500 hours working with inmates in search of their personal potential. She now works one night per week at the Restitution Center helping inmates set goals one small step at a time.

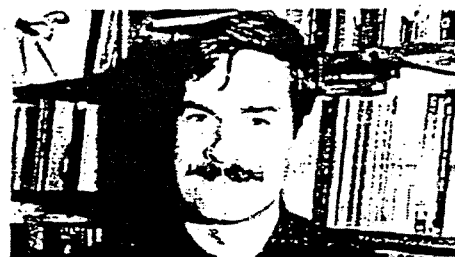
Another group of volunteers with a positive approach to the crime problem is the Screening Committee at the Restitution Center. Twice weekly, Gertrud Nasri (84 years young), Jim Horne (a local businessman), Ellen Lowe (of Ecumenical Ministries) and Joe Reneau (a close neighbor of the center) meet with corrections personnel to "staff" potential residents. Their primary responsibility is to consider the public safety of the neighborhood during the screening process.

During the first year of the program, 576 potential residents were screened. Assessing the potential danger of

inmates with criminal histories is a difficult and complex task. But so far, there have been no offenses committed by any of the Restitution Center's residents in downtown Portland. These volunteers believe that programs like the Restitution Center are a positive step toward helping individuals re-enter our community as productive members of society. Thus, they willingly give of their time each week to assist in continuing this community program.



The eighteen award winners and the fifty Citationists were chosen out of over 2,100 nominations received.

Although the nomination was not one of the final winners of the 1988 President's Award, its special volunteer contribution is representative of the irreplaceable contribution our nation's volunteers make. The decisions made by the final judges were extremely difficult ones because of the unique contributions made by each of the final nominees. The work done by your nominee and that of all American volunteers is the greatest resource that we have available to build communities that are safe, just and filled with opportunity for all Americans.


Certificates signed by President Reagan will be mailed to the Citationists in mid June. The eighteen President's Awards winners will come to Washington on June 10 to accept their awards from the President at a White House luncheon.

We appreciate your support in submitting your nomination this year and hope that you will participate in the President's Volunteer Action Awards program again next year.

Third Quarter Report: July, 1987 - March, 1988

## SUMMARY

This report covers Corrections Branch activities for the first three quarters of Fiscal Year 1988. While the custodial (jail) facilities remain at capacity, two of the three Release Programs are generally above their designated size. In addition, support areas such as Records and Court Services are coping with increasing work loads as the numbers of charged persons increases.

## CUSTODIAL/JAIL FACILITIES

Bookings Persons who are taken into custody by law enforcement personnel are initially booked into the downtown Multnomah County Detention Center (MCDC) or cited and released after being fingerprinted and identified. Those persons who are cited (in lieu of arrest) have usually received charges which fall into the category of non-jailable offenses.

Figure 1 shows the numbers of persons which have been processed at the MCDC reception area during these three quarters. The average number of bookings per month (2,206) is higher than the monthly average in 1986 (1,706) or even the first half of 1987 (2,081). Figure 2 displays the types of releases which occurred during this period.

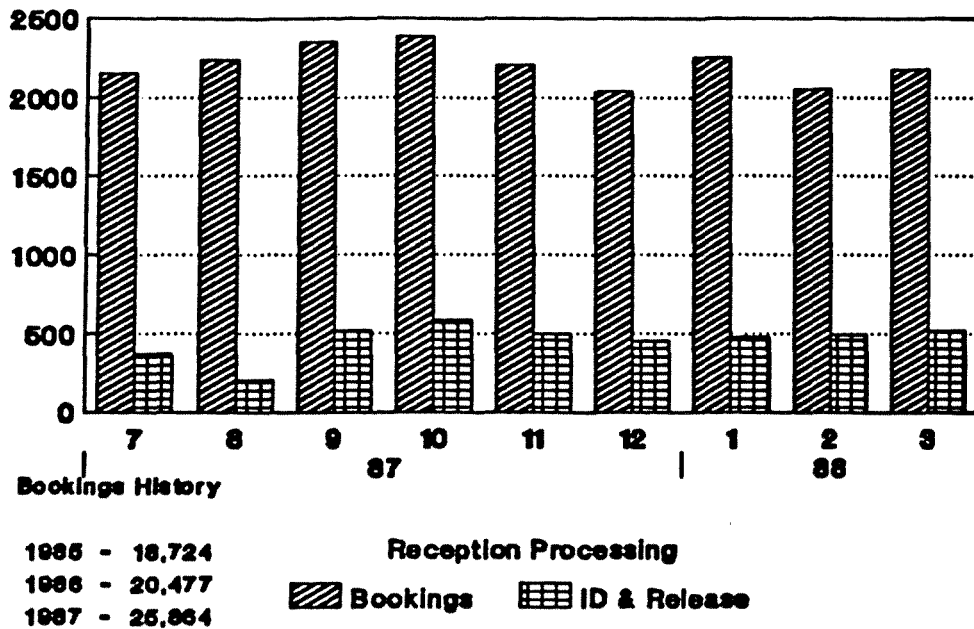
## Support Activities

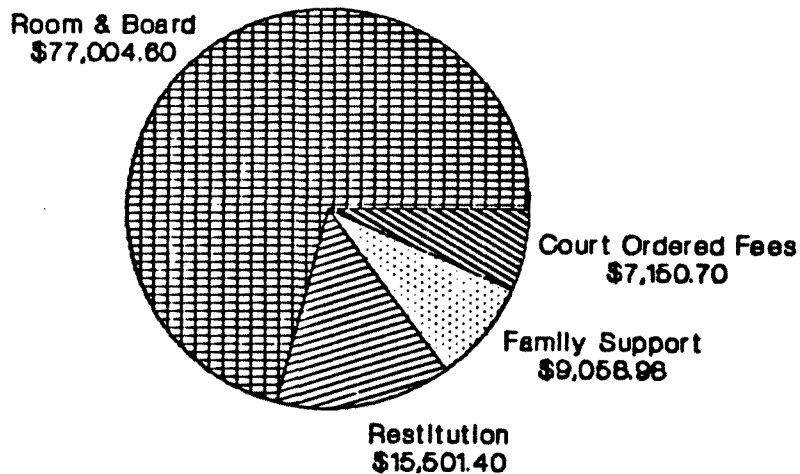
### Figure 3 Warrant Processing

Corrections Records is responsible for recording all transactions involving those within the corrections system from booking or citing through conviction or acquittal. Transactions include processing warrants, tracking bookings, charges and releases, scheduling transports and calculating release dates. Figure 3 pictures the amount of warrants processed during the past nine months. The average number of warrants received during this fiscal year (3,094) is up 13% from the previous six months' average (2,743).

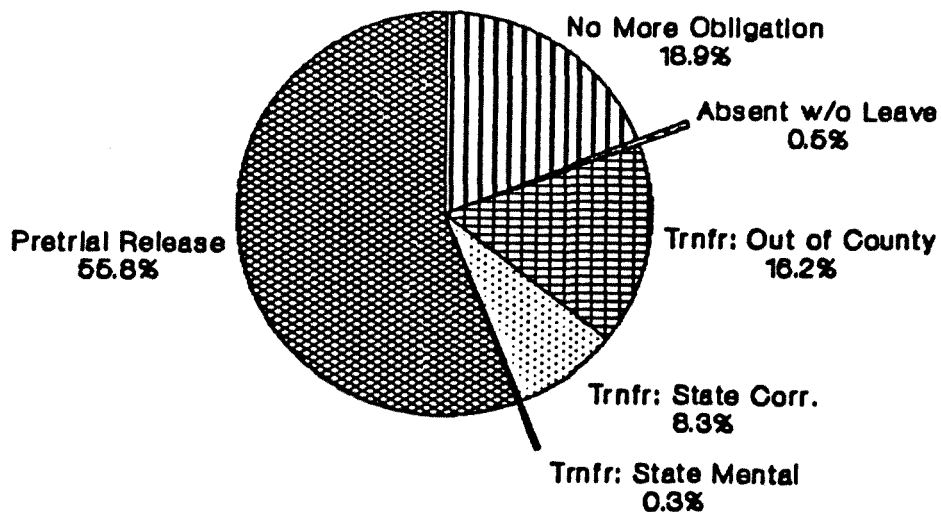
The Sheriff's Office Corrections Branch is responsible for transportation of inmates under guard between facilities, to receive medical attention and to appear in court. Prisoners must also be transported to and from the State prison system and hospitals as well as to and from other states. Table 1 summarizes the Court Services Unit activities by quarter.

Other support activities include holding and accounting for inmate property and money, laundry, commissary, general and law library, administration of the inmate welfare fund and security for the MCDC lobby and parking lot.

 (FY '88 - 3 Qtrs.)



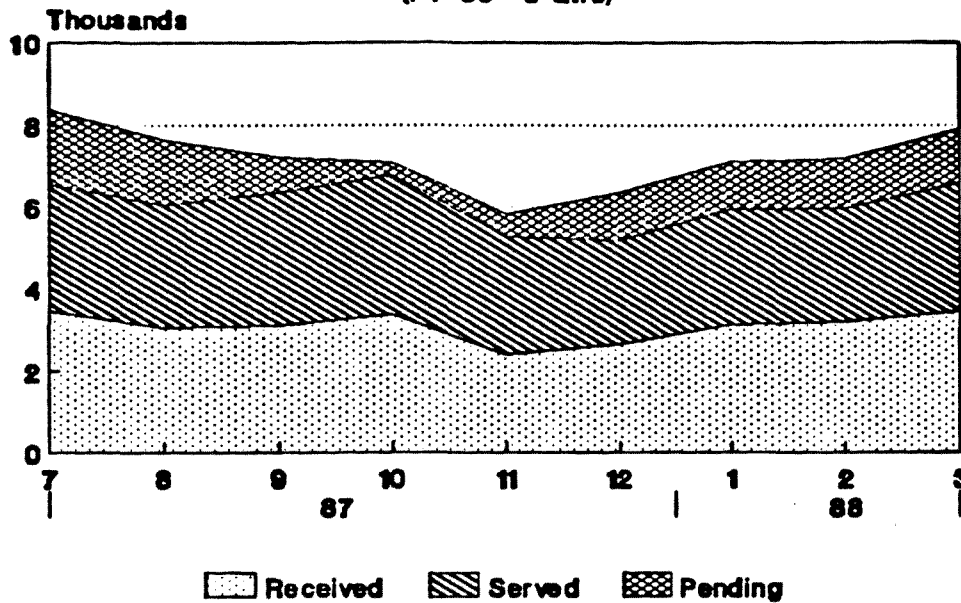
**Figure 2**

 (FY '88 - 3 Qtrs.)

## Inmate Programs

Programs for pretrial and sentenced inmates include a wide variety of counseling services (e.g. personal, financial), programs to combat alcohol (e.g. Alcoholics Anonymous) and drug abuse (e.g. Narcotics Anonymous) as well as classes such as "Unlocking Your Potential", "Thinking Errors" and Parenting. All inmates have opportunity to prepare for and receive a General Education Diploma (GED) for high school equivalency. Table 2 provides an overview of the GED tutoring and testing activities during this fiscal year.

On the average, participating inmates took two GED subtests per month with an average passing rate of 94%. During these nine months 100 inmates received their General Education Diploma.

Community volunteers are vital to the inmate programs provided by the Corrections Branch. Volunteers are involved in several inmate programs and support activities. During these three quarters volunteers averaged 393 hours each month. The value of their total time, even at minimum wage (\$3.35/hour), is impressive: \$11,842.25.

Restitution Center Sentenced persons who qualify can be housed at the Multnomah County Restitution Center (MCRC). MCRC requires residents to be employed or to actively seek employment. Earnings of employed residents are given to the center for disbursement. Thus residents pay room and board, court ordered restitution and court costs, family support, treatment and probation fees (see Figure 4). In addition, residents pay personal bills and voluntary family support. During one quarter--January to March, 1988--\$22,841 was voluntarily paid out for family needs.

In addition, MCRC residents participate in unpaid work activities benefitting several community agencies. During this fiscal year residents have contributed a total of 2,872 hours in such community work (see Table 3). Examples of these projects are:

- o Bulk mail assembly for:
  - Waverly Children's Home (200 hours)
  - Portland Art Museum (97.5 hours)
  - Portland Women's Crisis Line (95 hours)
  - American Civil Liberties Union (ACLU) (60 hours)
- o Stuffing underprivileged children's Christmas stockings for The Oregonian (94 hours)
- o Moving furniture for Central City Concern (124 hours)
- o Distribution of firewood to the elderly for Portland General Electric's Project WARM (70 hours)
- o Repackaging of food for the Interagency Food Bank's Project Second Wind (309 hours)

When other projects and time allow, MCRC staff are committed to conducting neighborhood litter patrol in the vicinity of the Center. This activity has averaged six hours each month.

Inmate Work Table 3 summarizes the various types and amounts of work performed at each facility. Inside the Facility: Inmates perform janitorial work as well as serving of food in all facilities. Sheriff's Office: Supervised crews of sentenced inmates work in the Corrections Branch laundry and perform other services such as painting and moving furniture for the Sheriff's Office. At the Multnomah County Correctional Facility (MCCF), sentenced prisoners who qualify have the opportunity to be part of public works project crews (e.g. Oxbow Park, U.S. Forest Service). Community Service: As described in the previous section, MCRC residents are involved in work service for a variety of non-profit community agencies.

Non-Custody Programs Three non-custody or "release" programs supervise prisoners who are not being held in one of the detention facilities. Population Release Monitoring, which opened September 1, 1987, maintains contact with pretrial inmates released by the Sheriff for lack of jail space. Close Street Supervision is a pre-trial release program for those assigned by the courts. Intensive Supervision is a non-institutional alternative to which the courts can assign sentenced persons. In addition some sentenced inmates are "furloughed" to Intensive Supervision by the Sheriff's Population Release staff. Table 4 provides an overview of the "success" rate of persons leaving these programs.

Population Release Monitoring is designed to serve 375 clients. Beginning in December, after just three months' operation, the case load has consistently exceeded 375 with a high of 486 clients to date. Intensive Supervision, intended for 50 persons, began to exceed its intended case load in late October. Indeed, during the last two months of the quarter (February and March), the case load has averaged 112 and has gone as high as 135. This is largely due to an influx of "furloughed" clients released by the Sheriff for lack of space. Both of these programs are operating with the original staffing levels. Close Street Supervision which was designed for 160, is, however, effectively maintaining this case load.

The Electronic Monitoring (often called the "Bracelet") Program serves all three of the Non-Custody Programs with two optional techniques that staff may use for maintaining contact with supervisees--electronic wristlets and automated telephone monitoring. Table 5 provides data on electronic monitoring in the first six months of operation.

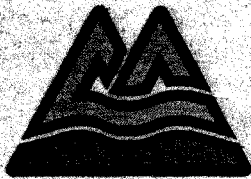



I am submitting this information in accordance with the Board's Administrative Rule AR 10.140 covering Specific Exemptions from the Public Bidding process. Although we are not requesting that the purchase of two Computer Aided Drafting systems be exempt from the bidding process we do request that the specification of name brand Graphic Adapter Board (item III C. in specifications) be allowed in the Request for Bids.

The purpose of this Request for Bids is to acquire the hardware for two Computer Aided Drafting/Design systems for use by the Road Engineering Section of the Transportation Division. The hardware consists of very fast, sophisticated Personal Computers and ultra high resolution graphics (monitors) equipment.

These systems will be used in conjunction with our two existing design systems and our one existing Drafting system. In addition to running "AutoCAD" drafting software the, systems will be required to run various other civil engineering and technical software packages. These systems will be used in the future to interface with the "Intergraph" computer mapping system at Assessment and Taxation.

Unlike standard personal computer setups, these systems contain complex math and graphic processing capabilities. Most manufacturers produce components with these capabilities but not all of these products are compatible with the software or hardware that we presently own. The software manufacturer must "support" your specific brand of graphics adapter board (the chips that are the brains for the monitor) for your system to work. Some of the technical software we use is not commercially available but produced by the Federal Highway Administration and will only run on specific equipment.

I have specified the Verticom H16 brand graphics display board in the Request for Bids as it is the only one supported by all the various software we will be running. It is an industry standard and is widely supported for the present systems we will be operating as well as when we expand into the existing Assessment and Taxation Intergraph system. It is also available from and serviced by most vendors that deal in Computer Aided Drafting equipment. This specification will not exclude any major vendors from bidding on this package.

The two graphics boards alone can cost \$6,000. It would cost as much to replace the boards if they were incompatible with our software or equipment, not to mention the down time it would cost us to reorder and install the new boards.

The estimated cost of the equipment specified in the Request for Bids is \$19,900. The Department of Environmental Services has appropriated funds for the purchase of these two Computer Aided Drafting systems in the FY 88-89 budget.

This equipment is needed by the middle of August in order for training to be scheduled before the next road design season.

Because the incompatibility of the Graphics Adapter Board is a major cause of problems in these sophisticated computer systems, and given that these systems will have to accommodate the variety of software and hardware that we presently use and will be using in the future, we strongly recommend that the restriction on specification of a name brand in the County Public Bidding process be waived.



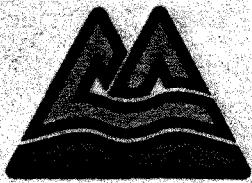

- C. The FAC assists the represented funders to determine strategic needs and priorities; it aids the development of coordinated responses and more effective use of community resources. The FAC recommendations should influence the priorities and resource allocation decisions of the represented funders, but the FAC has no formal authority to compel agreement.
- D. The FAC participates in the community action agency's planning process, reviews program/funding proposals for endorsement, and periodically evaluates the planning and service system on behalf of the funders.
- E. As the successor to the Emergency Basic Needs Committee, the FAC is to foster and continue the exceptional degree of cooperation and commitment shown in the work of EBNC.

#### SECTION IV. MEMBERSHIP

- A. The FAC shall consist of seven (7) members, who shall serve without compensation. The FAC shall have the following members:
  - 1. Multnomah County elected official;
  - 2. City of Portland elected official, as designated by the City Council;
  - 3. Housing Authority of Portland, Chairperson of the Board of Directors;
  - 4. United Way of the Columbia Willamette, Representative
  - 5. Representative from the foundation sector
  - 6. Representative from the religious community;
  - 7. Community Action Agency, Chairperson of the Board of Directors (ex officio).
- B. Representatives 4,5, and 6 shall be appointed in accordance with the Home Rule Charter.
- C. The FAC should meet quarterly (4 times a year) or more frequently as needed.
- D. Officers and operational procedures will be determined by the FAC members.

#### V. STAFFING

- A. The County's Emergency Basic Needs Coordinator and the City's Human Services Coordinator will provide staffing support for the FAC. Additional technical assistance will be provided by designated staff of FAC members.

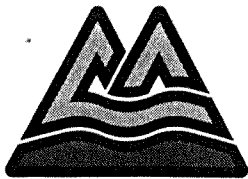
