General Information

1. What are you requesting from the Board?

On the morning of Tuesday, June 10, 2014, a student entered Reynolds High School, where he shot and killed a fellow student and injured a teacher before ending his own life with a self-inflicted gunshot. Local, state, and federal agencies, along with non-governmental organizations, responded to the shooting.

This briefing will highlight the County's completed After Action Report. The report is the result of a collaborative after-action review process that engaged multiple agencies and their response partners in order to strengthen preparedness for future incidents that require a multi-disciplinary and multi-jurisdictional response. As part of this process, Multnomah County Emergency Management established a review team that met with local agencies and non-governmental organization partners. At these meetings, the review team interviewed individuals directly responsible for the response, and collected additional data to support this review.

This brief will summarize the County's After Action Report for the Reynolds High School Shooting. The purpose of the report is to describe and constructively evaluate the response to the active shooter incident at Reynolds High School, including the actions taken by first responders and coordination among various local and non-profit agencies in Troutdale, Oregon on June 10, 2014. This AAR provides meaningful information

regarding the best practices and lessons learned as a result of the response, along with practical recommendations. The ultimate goal of this report is to provide insight that will better prepare response agencies and their partners across Multnomah County in the event of future incidents.

MCEM is not requesting funds to address areas identified for improvement at this time. Many items identified as “area for improvement” have been addressed or are currently being addressed.
