Stuart Emmons – Multnomah County Testimony
November 9, 2017

I was coming home from a movie last night

It was pouring rain and cold.

I saw a pile of belongings and nearby, a man behind a column.

His name was Ernie – he was 60, couldn't sleep, had been a plumber, had severe arthritis.

There are over 1600 people like Ernie living unsheltered on our streets in life threatening situations.

I came home and posted: "Our Portland Housing Bond could shelter every person on the street immediately and house every houseless person within two years. If we were truly bold, innovative and resourceful."

After my 2016 campaign for City Council, I worked for a startup modular housing company. The startup world of entrepreneurs and innovators thrive on hard challenges. They get to Yes when many people say it's 'impossible'.

We need to rise up and figure out how to shelter 1600 people, and soon house 4000 of our houseless. It's really not so big a number that we as Portlanders, you as County leaders, can't figure this challenge out.

Wapato can shelter 30% of our unsheltered. It should be a part of a solution.

Wapato is not perfect, but we have it, and it's pretty close.

Some Excuses:

"It's a jail" Give me, or one of County's other artist or architects a budget and plants and paint and 1 month and you will be amazed about how cool a place we could make

"It's too far away" Wapato is closer to downtown than much of outer east Portland, bus 11 could easily be slightly rerouted,

"It's too big" Shelters max at 100. Wapato is a series of 50 to 75 person independent shelters.

Excuses excuses excuses. Ronald Reagan did this. Trump. It's a regional problem. It's a west coast problem. It's a planetary problem. We don't elect people to make excuses. We elect people to get to Yes.

Back on the tax roles?

The deal is shady. If you approve this sale, there is a high likelihood of a legacy of a lost opportunity and 525 people unnecessarily exposed this winter. I've talked to many real estate experts and no one can figure this deal out. I've discussed this with Mr. Kehoe. I'm even more confused. The only conclusion I can come up with is: this buyer, inexperienced in industrial properties, has not figured this out. He just wants to make a buck and he doesn't realize he will have a facility that is worth less than 50% of what he bought it for. He'll probably bail anyhow after he figures it out. Meanwhile people will be exposed to life threatening freezing conditions this winter.

If you are insistent on selling this facility, then before you do it, find us a similar facility that can house 525 people that has heat, a commercial kitchen, medical facilities, close to a Tri Met line, within 3 miles of a MAX stop, surrounded by job opportunities, and is on a beautiful lake.

I get the No thing. We all need to come together and start saying yes. And do the math. How do we shelter 1600 people, house 4000 houseless.

If you can't figure out how to make Wapato into a shelter for people experiencing homelessness, then sell it to a group that can figure it out.

Or use it temporarily. For say 5 years and keep going to determine the optimal way to shelter 525 people.

Today you have been given the opportunity to surprise all of us and do something really transformational. Really exciting. Really bold. Open Wapato to Save Lives.
