Recently the Multnomah County Executive Budget for fiscal year 1992-93 was distributed. As in prior years, it just doesn't seem that there is enough money to fund all of the worthwhile programs which Multnomah County would like to provide. Therefore, we must again prioritize the limited resources available for service delivery.

The theme of budget year 1991-92 was to do more with less. With a resourceful and conscientious staff, the Sheriff's Office was able to do more with less. Please let me summarize some of the successes we have seen in 1991-92:

- * In August of 1991, the Inverness expansion was completed. Although delayed for opening until November, the addition of 254 jail beds greatly reduced the matrix releases we were previously making. Although matrix releases are occasionally made, the frequency has been greatly reduced.
- * On January 20, 1992, the Multnomah County Restitution Center and the Multnomah County Inverness Jail received accreditation from the American Jail Association. Both facilities received the highest accreditation score in the history of AJA accreditation.
- * Work crews at MCIJ again provided in excess of 80,000 hours of community service to county facilities and non profit social service agencies.

What does 1992-93 have in store for the Sheriff's Office? As you are aware, I was provided with a constraint number with which I was required to prepare a budget. This constraint number was the same budgeted amount as of December 31, 1991, and was not adjusted for inflation. This constraint number required that any inflationary growth in material and services be absorbed in existing baseline. I have little choice in adjusting my budget for inflationary requirements as the majority of them are contractual obligations with third party vendors. Critical to my continued operation at present levels is the funding of an add package to increase Material and Services line items. Specifically, the following items must be increased:

The initial constraint budget required me to close the Court House Jail as a 24 hour per day facility and convert it to a staging facility for the courts. However, since the Executive Budget was printed, I have become aware of another revenue source which is appropriate to use to keep this facility open.



On extraordinarily busy days, service attempts on some types of process can not be made at all. Additional fees could increase revenues to help offset the inadequate staffing levels which now exist. However, this does not address the present problem. The service of process in a timely manner is a mandated duty of the sheriff. Present staffing levels do not allow me to address this mandate. I have requested the restoration of the two civil deputy positions which were cut at mid-year.

The future of service delivery is changing. Priorities of the Board have been identified as providing a safe community for the delivery of services to children, the frail elderly, and those in critical need. The Sheriff's Office is a significant partner in realizing these goals. I share in that vision. It is my intention to increase my involvement wherever possible in community policing activities. 





SUBJECT: MULTNOMAH COUNTY DAY REPORTING CENTER

As you know, Multnomah County officials, (including representatives from Circuit Court, the District Attorney's office, Community Corrections, your offices and mine,) have discussed in earnest the development and implementation of a day reporting center for Multnomah County.

As you recall, last year a day reporting work group, comprised of Commissioner Anderson, District Attorney Mike Schrunk, Scott Taylor of the state's Department of Corrections, and Bill Wood from my office, met with a consultant to determine the feasibility of establishing a day reporting center in Multnomah County.

The work group on day reporting agreed upon three purposes for establishing such a center in Multnomah County:

1. Reduce population in county jail(s)
2. Provide sufficient options to criminal justice system to ensure full enforcement of sentence imposed by court
3. Reduce recidivism

Robert Jackson, Director of Community Corrections, in a memorandum to the County Commission, dated April 15, 1991, told the Commissioners that his office would coordinate a feasibility study regarding the development of a day reporting center in Multnomah County. This comprehensive study was to make recommendations concerning several key aspects of the center. The study was to be done in conjunction with representatives from my office, the District Attorney, Multnomah County Courts, and state corrections officials. Mr. Jackson assured the Board that his office would submit a formal report to the Board by July 30, 1991.

To my knowledge, neither the study nor formal report thereof was produced by the Department of Community Corrections. As a result, the issue of day reporting in Multnomah County lay dormant until very recently.

In February of this year, my office informed you that the Sheriff's Office would apply for a Bureau of Justice Assistance (BJA) grant through the Edward Byrne Memorial State and Local Law Enforcement Assistance Program, to establish a day reporting center in Multnomah County. This grant application would be under the BJA **discretionary** grant program, as opposed to the **formula block** grants, which are passed through the state to local governments. Under the discretionary program, each grant award amount will be up to \$2.6 million each. BJA requires each grantee to match 25% of the total project cost with a cash contribution.

Examples:

1. Total Project Cost: \$3.47 million
BJA Grant (75%): \$2.6 million (Max. award)
Matching Funds (25%): \$867,000
2. Total Project Cost: \$1 million
BJA Grant (75%): \$ 750,000
Matching Funds (25%): \$ 250,000

Obviously, the size and scope of the total project will be limited not by the amount of BJA grant funds available, but instead by the amount of County matching funds available.

On March 18 of this year, my office hosted a meeting of key County officials to discuss the development and implementation of the day reporting center. Present at this meeting were Judge Philip Abraham, District Attorney Mike Schrunk, Dave Factor of the Oregon Criminal Justice Council, Commissioner Sharron Kelley and her assistant Robert Trachtenberg, Bill

Farver (Commissioner Anderson's office), Mike Delman (Commissioner Hansen's office), Chief Deputy John Schweitzer, Sergeant Bruce McCain, and Larry Reilly of my office, and Robert Jackson, Cary Harkaway, and Horace Howard of Community Corrections.

At this meeting, Mr. Jackson unveiled to those present his own proposal for a day reporting center. This last-minute revelation caught my staff unprepared to respond to a patently competitive proposal. After much discussion in an attempt to reconcile the two proposals, the parties agreed to work together to submit from Multnomah County a single application to BJA.

On March 30, Mr. Jackson delivered to my office a copy of a grant application for a "Department of Community Corrections Day Reporting Center," together with a request for me to provide him a letter of support for his proposal.

I responded to Mr. Jackson that I could not support his proposal to establish a proprietary project by Community Corrections, when I was under the impression that we were to work jointly on a single application to establish a "County" day reporting center.

My staff then informed me that Mr. Jackson's application is not for a discretionary grant, but instead for a formula block grant. This technical distinction is further confusing since both the discretionary and formula grant programs are part of the Edward Byrne Memorial Law Enforcement Assistance Program.

I reluctantly agreed to support Mr. Jackson's proposal in my letter to Governor Roberts. But in so doing, I clearly indicated that the Department of Community Corrections and the Sheriff's Office are jointly planning to implement the day reporting center.

With this lengthy background before you, I now raise my concerns about Mr. Jackson's proposal to establish a "Department of Community Corrections Day Reporting Center."

1. The Community Corrections day reporting proposal calls for a budget of \$1.2 million. Of this amount, \$297,334, or 25%, will come from grant funds, while the remaining 75%, or \$907,889, will be matching funds. Of these matching funds, \$757,290 will presumably come from "County Assessment Fees."

My concern here is the lack of leveraging power this proposal generates. Assuming the County has \$750,000 to contribute to a day reporting center, it could leverage up

to \$2.5 million under the discretionary grant program. Instead, in its current proposal, Community Corrections is "leveraging" less than \$300,000 with its \$750,000 match.

2. Related to concern No. 1, is the fact that if the County appropriates \$750,000 to this project, there will be no chance of receiving a larger, discretionary grant because the County cannot raise the 25% cash match twice.
3. Another concern is the interplay between the Byrne formula grants and discretionary grants. As you know, we cannot use grant money to "supplant" an existing program; nor can grant money be used twice: as "match" funds for a second grant. In short, by taking this fast-track approach through the smaller formula block grant, the Department of Community Corrections is effectively killing the County's ability to compete for the much larger BJA discretionary grants.

I want to reiterate my desire to each of you that my office is willing to commit the time and resources necessary to ensure that Multnomah County is served by the most effective continuum of corrections options available. To that end, I will continue to extend an invitation to all County officials to work together toward this common good.

I look forward to your thoughtful and prompt response. The deadline for the discretionary grant application is May 8, 1992.
